Probably UNESCO has not yet received the covering Study Grant Forms for the missing students and therefore I would recommend that you do this immediately, through your Dar-es-Salaam Office and the Office of the UNESCO Education Adviser, UNESCO Regional Office for Education in Africa, in Dar-es-Salaam, to avoid delays in payment of the school fees.

At the same time, perhaps it would be advisable to co-ordinate with the International School in order to produce an updated list of ANC students attending the 1987 school year and if these are not covered by the Project Document, here again, please take up the matter with your Dar-es-Salaam Office.
