Dot Mkwanazi and I appreciated our consultation with Mandy Chinasamy on February 19th 1993.

In summary, we discussed/agreed as follows:-

- a) Dot Mkwanazi will become a Batlagae Employee as from this month, March 1993. Matla Trust will contribute R42,900-00 towards her salary, half of which, R21,450, will be transmitted to Batlagae Trust in March 1993 and the balance in September 1993.
- b) The total amount available from the FRESA allocation for the year March 1993 to February 1993 is R402,000-00.
- c) Batlagae Trust will finalize the Sacred Heart College and Phambili High School lists so that payments can be effected by Matla Trust. For mutual convenience, the cheque will be sent to the respective schools via Batlagae Trust.
- ${\tt d})$ All correspondence to the schools will be copied to Matla Trust.

since our meeting we have gratefully received cheques from Matla Trust for Sacred Heart College and Phambili High School and submitted them to the respective schools. Receipts will be submitted to you in due course.

The amount of R158,500-00 has been paid to Sacred Heart College for 54 scholars. Since the payment was made we have approved sponsorship for Nqobani Mkhwanazi, a standard one pupil, who is eligible for R3000-00 for 1993.

Phambili High School has been sent a cheque for R108,000-00 for 54 scholars.

The lists for both schools are not closed due to late arrivals and the delayed submission of the required documentation. We propose that we keep this open to the end of April 1993 by which time we'll confirm additional approved scholars. So far Matla Trust has transferred R266,500-00 from the FRESA allocation and committed a further R42,900-00, making a total of R309,400-00. A balance of R92,600 remains and we are currently indentifying other scholars for sponsorship with this amount. As soon as the list is ready we shall submit it to you. We shall try to restrict payment to one or two institutions. Incidentally, our report for 1992 together with audited financial statements will be ready by the end of April 1993.
