Introduction .
1. The inaugural meeting commenced at 10.27 a.m. with the Director-Generbl
(Political) presiding).- He welcomed all membe; s t6 the meeting, ahd stated thatw
the main assignment given to the Task Force was to look into the operations
and problems of the Albert Luthuli Memorial Trust Fund (LMTF). This he
added, was due to the incessant reports received by the Presidency which,
if not checked, might have some national and international implications for
Nigeria vis-a-vis the Nigerian/African National Congress (ANC) relationship.
He then called oh the ANC Chief Representative to give an overview on the
LMTF so as to enable members have a clear knowledge of the organisation.
2:: In his response, WE briefed the members on
the Luthuli Fund after a few preliminary observations. According to him, it
; all started with the excalating violence caused by the Apartheid regime in
```

South Africa last year. As a result of the violence, most youth had deserted schools and had gone into exile in the neighbouring Frontline States of

Zambia, Tanzania and Angola.

Thus in August 1990, the ANC Secretary for Education, when on-a visit to Nigeria, held dis'.cuss'ions with the then Director-Ceneral (Political) and . out the details with the Southern African Relief Fund (SARF) and the Federal Ministry of Education (FME).

- 4. Subsequently, a. team, drawn from the SARF and FME went to Tanzania, Zambia and Angola to assess the students. About 579 were found suitable. It was about this point in time that the LMTF with its Headquarters in London came into focus. The Trust Fund according to Mr. Nene, had been given some cash donation by the Australian Government through 'Austcare (a non-governmental organization from Australia) for the education of ANC students. It was with part of this donation that the LMTF was set up in .1.
- . Nigeria about mid-February, 1990. Thus an office was set up with a CO-t, ordinator, Councellor and a Chief Accountant and a few supportive staff (clerks, messengers, drivers) etc. Meanwhile, according to him, government was aware of the Fund and he had written to the MEA for its registration. i . The ANC Chief adged that, he had since rec_:_eiveo a feedback from MEA that his request was being looked into. He added that the ANC had to come in to assist the programme because of the staff running the programme were not sufficient. He announced to the meeting that Mr. R. S'belinge who was the acting Co-ordinator had been replaced by Mys. M. Skomolo who had just resumed duty. 'He informed the meeting that out of the 579 that were to be placed in Nigerian schools, only 1460 had arrived. And an of this number were under SARF sponsorship while the rest were on the LMTF sponsorship.

At the time of this meeting, he said, only about 39 students who were yet to go ,to school due to one reason or the other, but that arrangement had been made to get evening lessons for most of them whose admission had been deferred till the next academic session.

- 11. The Chairman again opened the floor to other members to ask questions, pass observations and comments on what had been said by the SARF and ANC/LMTF. A member from MEA suggested that with the problems facing LMTF, the government should have a perr'nanent representative in the Fund. This according to him would stem in future, such problems of admih'istr'ative lapses, IllegalIty etc. which the Fund had found Itself. Another member i191? according to him, was not good enough.
- 12. In his response, the Chairman informed the meeting that these issues would be tackled along with others when the Task Force had worked out a methodology for the assignment. He then requested members to give their suggestions on the procedure(s) to be adopted: by the Task Force in doing the assignment. At this juncture, the member from the Australian_l;l_ig_h Commission re uested to withdrgwmm Task Force as she? had little or nothing to contribute on the internal working of LMTF. The ANC Chief Repr resm expressed fears on the assignment of the Taskforce. He wondered if the Task Force was set up on a permanent basis to monitor the affairs of the Fund. The Chairman once more allayed his fears by explaining to him that the purpose of the Task Force was .../6.
