MESSAGE : I

We refer to your telefax of date 13May, 1993, addressed to our Treasurer-General. Mr. T.T. Nkobi, wherein you express concern about the fate of the steel structure buildings donated to ANC by the Danish Government. In his message of 5 April to Rev. Christian Balslev-Olesen, Mr. Nkobi informs of the intention of the ANC Treasury Secretariat to proceed with the erection of these structures in Dar-es-Salaam and, subsequently, to construct new buildings at the Ka Ngwane School Project.

This decision is necessitated by ANC no longer having the technical personnel capable of supervising the packing and shipping these structures since the closure and hand-over of the Tanzania projects. It is therefore the intention to construct these buildings in Tanzania under a turnkey contract with one of the larger locally-based construction companies, with whom we have worked over the years. Accordingly, a draft contract has been drawn up in consultation with this company to implement this project. At this stage, all preparations are in hand to begin construction works on the ground.
