SELECTION OF A RAPPORTEUR

The Meeting selected Cde Zama to record the proceedings. URGENT MATTERS REFERRED BY THE TASK FORCE Staffing levels and budget

The Meeting heard reports on staff requirements of the various departments and production units during the phasing-out period. It was agreed that the main objective should be to ascertain minimum numbers of ANC personnel required and, also, those who are willing to stay on during this period. This data will allow for the preparation of a budget to be presented at the SIDA talks and also to other donors.

A proposal on salary scales based on a personnel component of i 90 people in DSM, M28 and DKw was tabled and discussed. The Meeting agreed to forward a proposal of a 4-tier salary scale system of 1500, 1200, 1000 and 800 USD, plus housing and ANC health facilities. This system would cost approx. 1 million USD/year. A subcommittee (Mpho, Bizzah, Jackie, Don, Kenneth, Zwelakhe) was appointed to determine the absolutely minimum ANC staff requirement. The subcommittee will report back in the next meeting.

RE-STAFFING OF THE DIRECTORS OFFICE

Cdes Pule and Sasha were proposed as candidates for Deputy Director for M23 and DKw. Pule was appointed as Acting Director during Cde Makopo's absence. Cde Thabisa was proposed for secretary and Cde Jimmy for Bursar. These comrades will be approached.
