We thank you for your letter of the 11th October 1993 and also the letter you addressed to our clients on the same subject has been handed to us with instructions to advise that no injunction has ever been granted by the Court and request you to henceforth desist from writing to our client directly.

In good spirit our clients made an offer to yours which is not acceptable to your client, the said offer is not out of legal obligation but as a humanitarian gesture of goodwill but it appears your clients attitude is one of forcing our client to accede to her demands and is now prevericating the situation rather than adopting an attitude of reconciliation, and we now have instructions to litigate this matter to its logical end. You may advise your client that in that event she may end up with nothing and paying our costs.

We are also instructed to advise that your clients claim that she has her relatives living in the house (Green House) is false and mischievous.

It is common knowledge to our client and yours that she has placed tenants in the property from whom she is receiving rent and we now have instructions from the beneficial owners of the house (Green House) to evict your clients tenants as trespassers and we will in due course be serving them with proceedings.

In the meantime unless you deliver and serve us your statement of claim within the next 10 days we shall apply to have your clients action dismissed for want of prosecution
