RE YOURS DATED THE 30 OCTOBER 1991, I AM SORRY THAT MY FAX LETTER T0 YOU DATED THE 28 OCTOBER 1991 WAS NOT 100% CLEAR. I DID NOT MEAN THAT YOU SERVED THE LMT FROM THE 1 JANUARY - 30 JUNE 1991. NO! THE TRUE POSITION IS THAT WE ARE RE-QUIRED UNDER THE LMT/AUSTCARE CONTRACT T0 SUBMIT A REPORT T0 AUSTCARE FOR THE PERIOD 1 JANUARY - 30 JUNE 1991 AND EVERY . SIX MONTHS THEREAFTER. I THEREFORE FUCUSSED ON THIS PERIOD. WE ARE, OF COURSE, AWARE OF THE SERVICES YOU RENDERED FROM SEPTEMBER T0 DECEMBER 1990, EVEN BEFORE THE LMT GOT INVOLVED IN THE PROGRAMME AND 1 JULY 1991, T0 DATE. HAVE DEPENDANTS TO SUPPORT, TO KEEP ON STAYING IN LAGOS WILL NOT BENEFIT ME IN ANY WAY. I AM FOREIGNER HERE, I ALSO DO NOT WISH TO NATURALIZE HERE, I CANNOT EVEN BE ALLOWED TO SHVK EMPLOYMENT, ACTUALLY I DON'T EVEN WISH TO. PLEASE HELP ME SECURE MY PASSPORT, I WILL SURELY FIND MY WAY BACK TO SOUTH AFRICA EVEN IF IT MEANS WALKING, I SHALL SURELY DO THAT. I DON'T THINK IT IS YOUR WISH TO SEE ME FRUSTRATED HERE, IDLING HOMELESS AND SLEEPING UNDER BRIDGES OF LAGOS WHEN THE AHC (SA) PROVIDED ME WITH THE MEANS OF SURVIVAL I.E.
