RETURNED STUDENTS

Comrade Makgothi informed the meeting that the whole question of what to do with returned and expelled students is being discussed by the NEC. Input from the Directorate would be welcomed to further this discussion. Therefore, our decisions should be regarded as recommendations to the NEC.

The following points were made:-

- It was felt that the role of the Department of Education, Scholarship Committee, and Department of Manpower needed to be clarified. Which one is responsible for dealing with returned students?
- A body is needed which will be responsible for monitoring the progress of students in placement on a regular basis.
- The meeting was informed that the opinion of the akawa Administration was that new and returned students should not be separated, since the enthusiasm of the new students seemed to be a favourable influence.

The following recommendations were agreed to by the meeting:-

- 1. Minimum length of stay at Dakawa to be:
- a) Those from home 3 months
 - b) Those returned from placement for
- i) Academic reasons time of admission to SOMAFCO or another Department will depend on the content of the official report on that student.
- ii) Indiscipline individual cases will be judged on the basis of the official report.

Gross indiscipline - probationary period of 12 academic months. uring this time the person will be closely bbserved. At the end of the period, a report, will be given by the Dakawa dministration. A dec ision will be made on the basis of that re port. .sb. sb. sb. st. in the st.

- 2. Intake to SOMAFCO will only take place at the beginning of the academic year and at the beginn ing of the second term.
- 3. Cases of drug and alchohol addiction should be treated seriously and dealt with in a proper manner. Comrade Makgothi was requested to take this up and to see that the necessary facilities Makgothi and personnel be made available.

SILVER COMMISSION REPORT

One item of the report stated that there had been no briefing, Cd. Dennis challenged this, stating that a full briefing had been given by himself. Reddy Mazimba, Ntilashe, Makgothi and Mbali, but that the Commission had never gone into this question. Cd. Silver replied that this had not seemed necessary since 'd. Ntilashe was a member of the Commission and at no point did he deny the allegation.

The meeting decided that the allegations against the Mazimbu leadership must be investigated and cleared upbefore the report could be considered.

The Commission is to take the necessary steps and submit a final report to the next Directorate meeting - August 29.

4. Letter from the Principal to the School Matron informing her that material taken from the building site for her fence and garden had been returned to the site.

It was pointed out that all houses should be subjected to the same rule and the Principal stated that he had sent a memo to this effect to staff and students.

5. Letter from Matron Ngalo to Chief Representative re their children staying in their residence. Comrade Maseko gave a detailed report on the background to this issue, indicating that in principle, a family had the right to stay together provided certainrules were not violated. In this case circumstances necessitated the removal of these students to the dormitories.

Cd. Mazimbapointed out another aspect. That there was lack of parental control resulting in indiscipline and misbehaviour regarding school regulations.

The meeting supported Cd. Maseko's recommendation on the temporary removal of these children to the dormitories until such time as the accommodation position permits their return home. Cds. Mabizela, Msimang, Dennis and Ntilashe were appointed as a delegation to speak to the Ngales.

DEPARTMENTAL REPORTS

1. Building Project - Landscaping in Unit 2 has been completed Work in the Dormitory blocks will be finished in a few days when they will be handed over to the school. Progress on the dining hall awaits material.

Other structures are in progress and work on Unit 5 has begun. Also work on the second street of houses will start soon. The material shortage is very serious at present and imports are be coming increasinglyimportant. There may be delays towards the end of the year because of the shortages

2. Commissariat The school Commissariat has been functioning for two months and is showing much promise. The structure will be fully functional by the 1982-83 school year.

Implementation of the Mazimbu Commissariat has not yet been effected.

A programme for the Dakawa Commissariat has been established, and Cd. Nku, has arrived to assist Cd. Sello. One probes he arrived is the exploitation by some elements of the lem being faced is the exploitation by some elements of the discontent arising from food shortages. It was suggested that a campaign be launched by the Commissariat on our whole community about the food situation in Tanzania. Cd. Makgothi suggested that in future we consider Dakawa as a venue for events whenever possible. This should help to boost morale. It was agreed that a day of work at Dakawa be incorporated into the Youth Conference Programme. A work programme, tools and transport must be arranged.

Extra supplies for special events will be discontinued, since this contributes to the shortages. A consignement of tinned foods has been received from the OAU.

Comrade Premie Appalraju has accepted the position of Dar buyer for the ANC. She has been briefed and will soon begin her work.

Some comrades are still living with Tanzanian women without being legally married. ew cases in this category are Junior, Sam Ledjuma, Edward and Tanda. This situation must be regularised. He was then transferred to SOMAFCO, where his performance has been troublesome, including lack of attendance, theft and defiance. All means to remedy the situation have failed. The meeting agreed that the Chief Rep is to make the necessary arrangements with the RC to have him dealt with.

Dakawa Students Mandla continues to take students to Medical Point, claiming that he has the support of Cd. Dennis and the Directorate. There is no such support. There must be an immediate investigation of the situation at Medical Point, and our students withdrawn if necessary.

It is to be made clear to Cd. Fuzile that no student is to be released from Dakawa without authorisation from the Directorate.

Sikosi reported that since she was a married woman and was sent here specifically to teach, she did not fall under the jurisdiction of the Charlottes.
