We refer to the above matter and are pleased to confirm that judgment was delivered by the Magistrate at Lobatse on 31st August 1987 in the following terms:

- Kgosietsile Molema was acquitted on all charges and discharged;
- 2) Elias Mokoto was acquitted on the main charge of Possession of Arms and Ammunition of War and convicted of possessing one arm (a pistol and assorted ammunition) in respect of which offence the fine of Pl50,00 was imposed, or in default of payment the term of two months' imprisonment. This fine however is not payable by reason of the fact that the default term of imprisonment has been deemed to have been served.

The writer has been informed that you are returning to Zambia by plane this afternoon and we extend our best wishes to you both.
