REBUILDING A LEGAL AFRICAN NATIONAL CONGRESS WOMEN'S ORGANIZATION IN SOUTH AFRICA

INTRODUCTION

The unbanning of the African National Congress and of other democratic organizations has placed before our entire movement the challenge to re-examine our strategies; our strength and weaknesses as well as our methods of work.

Throughout the years of illegality, the women, in their various democratic formations, but significantly in community action, have provided a powerful force in opposition to apartheid. Their local and regional formations have given immense strength to the Mass Democratic Movement. Their organizational strength within the unbanned ANC will ensure the sustained dynamism and organizational strength of our movement.

The new situation demands that the ANC Women's Section re-organise and transform itself into a popular and dynamic force in the form of the ANC Women's League. The League should draw into its ranks the most oppressed women who live in the rural areas and all the Bantustans. Working women, church women, students, academics and professionals; young and old women of , all races and creeds should find a comfortable home in the ANC Women's League. Their emancipatory aspirations will be met by the League's adherence to the basic principles, policies and programme of the African National Congress

The African National Congress has committed itself to a united, democratic future free of race, gender and other forms of discrimination. In general, it will be the task of the ANC Women's League to ensure that the ANC Programme addresses correctly the particular needs of women. The League will highlight all forms of discrimination against women; promote affirmative action; monitor implementation in all areas of human endeavour and initiate appropriate research among other activities.

WORKSHOP OBJECTIVES

The NWEK working group which met on 11th February 1990 reviewed these fast moving developments and decided that the tasks ahead require a much broader consultation between the NWEK, and regional representatives from inside the country and those in exile. This consultation will take the form of a workshop whose main objectives will be as follows:-

1. To re-examine our tactics;
2. To assess our strengths and weaknesses inside and outside
3. To re-examine our organizational structures and modes of operation. inside and outside.

It is recommended that this workshop be preceded by local and/or regional discussions on implications for the ANC Women's Section of the unbanning of the ANC.

Immediate and practical goals to be achieved by the end of the workshop are as follows:

- A Programme of Action for Re-building the ANC Women's League upto December 16th 1990 (ANC National Conference)

- A Provisional Constitutional Framework Of The ANC Women's League (A proposal);

- Identification of a Working Group for Monitoring the implementation of the Programme Of Action.

DYNAMICS OF THE WORKSHOP

The workshop will encompass the diversity of subjects relating to the mobilisation of all South African women; Such as the history of the ANC women's organisation inside and in exile; Current situation (strengths and weaknesses); implications for legal mobilisation; relation of the ANC women's League to other democratic women's formations and the relation between the ANC and the Women's League.

There will be plenary sessions where formal presentation will be made. Each presentation should ideally take 15 minutes, followed by 30-45 minutes of discussion.

Plenary presentations will include:

- Do we need a Women's League In the African National Congress: Positions for and Against (ANC National Organiser plus 2)

- Women in the ANC: A Historical Note (Sisulu and Njobe)

- Mobilisation of Women in South Africa: Strengths and Weaknesses and new tactics;_ (Paper From Inside and Zuma)

- Provisional Constitutional Framework of the ANC Women's League (A draft document for discussion)

- The Way Forward: A Draft Programme Of Action

- Women and Economic Development: Women must participate in the debate on Nationalisation and women's place in a future economic order.

Participants from inside and outside must prepare for substantive participation in all these subjects. The steering Committee Will decide on actual presenters.

or Yes, he has gone beyond what any of his predecessors had done; but we should not deceive ourselves into believing that he is ready to accept the type of transformation that are essential to improve the lot of our people. Such transformations can only come about as a result of our purposeful actions. Key to this is a strong ANC pulling together with other democratic formations of our people.

In an attempt to extricate the regime from the present Economic; Political and moral crisis, de Klerk has been forced to open some space for our movement. His historic unbarring of our movement and other organizations as well as the release of our leaders must be viewed in this context. They are grudging responses of an enemy under pressure. These of course are important victories for our people. Our task now is to ensure effective use of the legal space created to ensure the rooting of our movement and this perspectives among the masses of our people. This is a task of

fundamental importance. It is the only way of ensuring that the gains that have been chalked up are not reversed. We have a historical duty to turn this forced retreat of the regime into a rout. Our meeting here should be seen as part of our attempts to attain this noble objective.

Since his inauguration as State President apologists of the regime have been trying to portray de Klerk as a very reasonable man with the interest of the black majority at heart. On the other hand a campaign of slander against the ANC and M.D.M. has been launched. - a

The aim of all this is to portray the regime as the good boys and us the bad boys in the South Africa political equation.

Whilst we undoubtedly still occupy the political and moral high ground both at home and abroad we should nevertheless not underestimate the impact of these attempts. He should at all times be vigilant and close ranks. ('WW?E\$\$\$49%FIJ

We should expect an escalation of the campaigns against us; we should refuse to concede even an inch of the ground we have covered to the enemy. URGENT TASK OF OUR REVOLUTION

A number of conditions put done in the Hearer declaration as essential far the creation of a climate conducive to negotiations have not as yet been met.

The set has shown that it is incapable cf stopping the violence in our areas and ;should be lifted. Throygh mass action we must force de Klerk to meet these demands.

As we build our structures we must ensure that they are built on the solid foundation of discipline and accountability, Our people must feel that the movement is theirs and that they shape it 5 direction and programmes.

We took note of the recent atrocities against our people in Sebokeng and Natal. We noted with concern that our people in such instances lack the capacity to effectively defend themselves. W ,71 _ , ,ht..t.r

We therefore resolved to urgently improve the capacity of our people to defend themselves their organizations and their leaders.

In the past we faced numerous problems in rooting our army amongst our masses... We lacked a viable underground and well established reception points. We noted also that there were instances when our combatants behaved in a manner unbecoming to members of our peoples army. We felt that the present situation offers vast opportunities for improving these weaknesses. We also reaffirmed that suspension of combat actions is conditional upon the enemy restraining its security forces and that we cannot be expected to disarm our people in the face of an intransigent enemy.

CONCLUSION; -

The tasks you, face are enormous indeed you are called upon to assist in formulating strategic perspective for our movement as well create a viable. instrument to carry that perspective through

We are in no doubt that you will accomplish this task. May you ;also deliberate on an issue of strategic importance for our army. We need to neutralise significant-sections of the enemy armed forces. They have wives and children. Is it not high time that we work out a clear strategy of deliberately working on these families so as to make it impossible for them to shoot our people. Personally, I think we should treat this as ;an important task of our Women's League.

Lastly, specifically on behalf of our ;army I wish your deliberations every success. , , 3 '
