MINUTES OF THE MAIN MANAGEMENT COMMITTEE (MMC) - REPATRIATION: CHILDREN OF RETURNEES HELD ON 25 JUNE 1991 IN ROOM 1010 CIVITAS BUILDING AT 9300

- 1. The meeting opened with a prayer by Dr E' Auerbach. The chairman welcomed all present and he explained that the agenda should be regarded merely as a guideline for discussions and that committee members should feel free to introduce new items. - 2. The meeting confirmed that the three major role players in this exercise were the NCCR, ANC and the government.

Both ANC and NCCR have had an opportunity to visit Hillview C4aWBve: . . . .
