The meeting decided to convene a Conference of Patriotic Farcee. aimed primarily to unite the Oppressed. All representatives of organised groups and bodies who support a Constituent Assembly should be united to this conference. In the meantime the ANC and PAC resolved to approach all those still not committed to a . Constituent Assembly, with a view to encouraging them to participate. The Patriotic Conterence will take place in Cape Town during August 1991.

The meeting created joint structures to implement these and other decisions. A special joint eubecommittee on Sanctions was appointed.

The meeting was an outstanding success and in the words of the closing addresses of the two leaders "exceeded our beat expectations."
