Meeting held between the Administration and the TGO Committee on the 19/3/93 at Chief Rep's office.

Agenda:

- a) Chaane's Warehouse, Green House and Zapu House
- b) Payment of the doctor and other arrears
- c) Groups coming from Tanzania
- d) Evaluation of Cars for staff
- e) Co-ordination between Admin and TGO Committee

On the Chaane's warehouse he pointed out that he did not know that the ANC was no longer in need of it.

It was then resolved that in the meantime the ANC should look after it whilst Chaane will look around for prospective buyers or people who might be interested to buy it. He also requested staff members to help him in looking for interested parties.

On Green house it was pointed out that the old lady has misunderstood the generosity of the ANC. That infact the ANC originally gave her the house from a moral standpoint and that after that she decided to demand compensation even for her dead son and it was then that the TG nullified the deal.

It was then decided that Mr Aziz Adams will be asked as to whether he did write a letter to the authorities seeking her eviction.

The administration also question as to why HQ did not inform the mission in writing that they had donated a house to KK instead the office got the news through KK's son Tilyeji.

The TGO Committee also revealed that they were not formally informed of the development but heard it from people as they were not also in the meeting.

It was however pointed out that Comrade Moosajee is the one who attended the meeting so he will brief the administration when he comes back.

On Zapu house it was decided that Comrade George Naicker should try to see the company involved so as to speed up the renovation work so that the structure can be given to the Zimbabweans.

On the issue of the Tanzanian group the meeting felt that the issue has been raised with almost all the structures at HQ and their response (TGO and MHQ) was that the group should be sent back home. That as far as they are concerned the group is no longer a responsibility of the ANC and among them there are enemy agents.

However some of the views of the meeting where that it will be wrong to approach this problem from a military and financial point of view but it should be looked from a political point of view. It should not damage the image of the ANC. That the group are highly trained and if they join the other side the ANC will be playing.

After a long debate it was finally resolved that since the mission gets its resources from HQ it can do nothing to solve this problem as it is out of funds and it must just follow the advice of the HQ that the group should be rounded up and sent back to the camps.

On the issue of having sold Kwasa-kwasa's (Aaron) residence Comrade George Naicker denied but the meeting pointed out clearly to him that the comrade is not yet indemnified and he should have a house to stay in.

On evaluation of cars to be bought by the staff the meeting noted that the issue should be speeded up because if it is delayed it might cost the comrades concerned a lot of money.

It was also pointed out that the cars should not be evaluated by an outside force it should be done the same way that the first batch of cars was evaluated.

That when sales are done the TGO Committee should consider that it is selling to ANC members. It was then resolved that the issue will have to wait for Comrade Moosajee.

The issue of comrade collecting rents from local people resolved that the people involved will have to be told that if they continue doing so the houses will be taken by the ANC.

The meeting also called Comrade George Naicker to order on his seemingly undeclared war against the office. It was called to question as to why he did not raise issues with the office but runs to HQ and use the leadership to intimidate the office.

Here the question of the twin cab car was mentioned.

It was then resolved that whenever there are problems they need to be raised by both sides and not piled up. That dialogue is the best form of resolving any differences.
