

- 2. For the Cultural meeting requested by Lusaka for the 23rd 25th February in Harare, CCFT booked the venue (Oasis) and the accommodation (Monomatapa). As Barbara is in town to attend the meeting with the US Foundations we should be able to discuss the organisational details with her.
- The preparations for the ANC-CBM meeting are on line. Lydia pointed out that the Sheraton requests the full amount for accommodation to be prepaid in foreign currency. That means that we need a definite confirmation from both sides that the meeting takes place as planned.
- ZISA has accepted the request to facilitate the travel and accomodation for 13 participants from South Africa. SACTU should come back with the details. In addition ZISA awaits concrete requests for the other two meetings indicated by SACTU.

ZISA shall try to get funding for the SACTU badges.

In the placement programme we are still waiting for approval by Government. It was agreed that the main reason for the programme is to give the applicants the possibility to gain professional experience. On this background the fact that the Ministry of Legal Affairs turned down one applicant for lack of experience contradicts the aim of the programme.
