The Panamanian Delegation recognizes that the approved Resolution, which Panama voted against, contains positive elements such as:

.

- The reaffirmation of the principles of respect for the people's

right to self-determination and of noninterference in the internal affairs of other States.

- The call on all States to refrain from unilateral actions that may obstruct a just and negotiated settlement.

- The reiteration of the importance the Member States give to

the strict fulfillment of the Torrijos-Carter Treaties.

These

elements clearly urge the United States to put an end to its - current aggressive and interventionist policy against Panama.

The Panamanian Delegation shares the interest expressed in the Resolution regarding the need to develop a democratic process which, by means of free elections without foreign interference, can lead to the establishment of a new government in Panama. This is exactly the official and public commitment of the present Provisional Government of Panama, which has been reaffirmed before this Assembly, and whose fulfillment depends exclusively on the ceasing of the United States' aggression.

However, the above-mentioned Resolution does not adequately denounce the present aggression of the United States of America against Panama, which constitutes the only international aspect of the so-called Panamanian crisis and the main obstacle to the country's administration.

The Resolution contains Judgements and explicit affirmations that violate or are incompatible with Articles 1, 3, 12 and 18, among others, of the Charter of the Organization of American States.

Consequently, the Panamanian Delegation declares that it reserves itself the right to adhere or not to the actions deriving from this Resolution.
