Majola again came to Nzima and tdkd him he had problem:s with his family .f' and asked if the boy could be moved to another ANC residence. We than i arranged for the boy to be removed before he was taken out of the louse. Code Nzima further said the boy is an ANC member because he was called at the DPM's officeon the 10th.:r2' we

Code Nsibande said Hi we went to XKE?Majola' 5 place with Code Zanele; Mia. Majola complained a lot about the boy's presence and that he leaves home in the morning and come back at midnight, She (Mrs. Majola)iaid the boy is'l friendly with people who hate the ANC . She said she is scared of this boy nd furthersaid we should find another accommodation for the boy or she _ 'ibves out of the house. She gave us an impression that she does not like the bOyo

Code Baartman said the boy was called to the office at No.6 By Code Zanele fo an intervmew , he spoke to him together with Code Mampufu, Mashigo, Solly and? Vundla. The boy told us that he wanted to go back to school. Arrangments were made that he attends night sohodb. We told him to be clear and be prepared to work together with us.

Code Mohlathe said, as Code Ndlangisa has said we must look things all noun: he continued saying he was working with Code Majola for sometime, he knew . thre was an misunderstanding between the family as a result he suggested that the boybe taken away from him later. Code M6hlath took the boy to Code Moletsane' splace, because he is now mentaly distur ed and has a very bad attitude about the ANC because of the life he has led With his family. dee Baartman suggested that the boy must be under contgga . Cote Code? Baartman, I can see he_ is mentally disturbed, he must not roam about with the nonpalliance group, he is moving about with this Lukhele boy and he ., must reduce his friendship so that we agree that he be given the food supply. 'The house agreed. Code Baartman also raised the case of dee chethwa's daughter, Zinhle, an ANC member, who is staying with the in-lags. . Code Baartman suggested that we must see to it.that the children are taken care Code Nzima raised the point that Code Moletsane's case was reported to the RPG byi'the Education Committee as he is one of the committee members, and they requested that he be given the food supply and the house-ggreed; .Code Rdlangisa continued saying it was a terrible thing to see Moletsane driving the school bus as he was not reported to the RFC as a member of the organiser ion, we felt our children were unsafe.

Code Baartman said, we all agree that Moletsane?s case is over and that:he is one of us, and should get the monthly supply, but I would like to see him. Code Mohlathe suggested that Code Baartman and Code Moletsane can meet , but not at No.6 because Code Moletsane is underground, they were to arrange their-place of meeting. Code Baartman suggested that thxxxhnnix we must protect the region as there are too many people sent in by has enemy. Code Mohlathe suggested that he'd recommend a walkie talkie to be installed or7 C.B. for emergencies. Code Nzima said we are not allewed to have such things. Code Ndlangisa raised the point that the house owner came to the stores, I was with Code Zanele they walked around the house checking every corner, after about 30-40 minutes they joined Zanele in her office only to find that they w each other from home and tLhe man with whom this woman arrived was e Zanelets relative than they started to tell us that as we see them here the house owner has had telephone calls from an informer to come and see the people occupying her house, they are terrible people. The informer even sent her grandchildren to tell their grandmother to immediately see her or else her house will be damaged. She even told us who informed her, she was very much against the informer. The informer is one of our neighbours, so something must be done very soon or else wu are in danger. . Meeting closed 10.00 a.m.
