Any funds provided for the Project which are not spent by this date, or are in excess of actual Project requirements, shall be refunded to the Receiver General of Canada in care of the Embassy.

Until informed in writing by the Embassy that the Project is officially "closed", Mthimba will maintain and retain, accurate records relating to the Project detailing all disbursements from the Contribution in a such a manner that they can be clearly identified and verified. Mthimba shall keep available for audit and evaluation purposes all documentation pertaining to the utilization of the Contribution including official receipts, invoices, accounts and all such records as may be required to fully and uniquely account for the entire Contribution. Mthimba will afford Embassy and other Canadian Government representatives proper access and facilities required to conduct such audits as may be required.

4.0 Announcemegts and Ceremonies

Mthimba will acknowledge the Contribution in any reference made by it with respect to the Project in publications, speeches, press releases or other similar matters.

The Embassy reserves the right to publicize the Canadian Contribution both within South Africa and abroad.

5.0 Monitoring and Reporting

During the course of the implementation of the Project, Mthimba shall permit or cause to be permitted any authorized representative of the Embassy reasonable access to the site/s of the Project for purposes of inspecting and assessing Project progress.

At the completion of the Project, Mthimba shall submit to the Embassy a Final Report which shall include a summary of all Project activities funded through the Contribution, a commentary on Project implementation relating actual results achieved to the Project's goals and objectives as stated in the original Project Proposal and a final audited financial report. This financial report shall be supported by original or copies of all receipts, vouchers financial statements and other documents pertaining to the disbursement of the Contribution.

Unless the Canadian Contribution can be clearly and uniquely identified therein, general implementation and financial reports are not acceptable.

5.4 The Final Report for the Project must be received by the Embassy no later than 31 October, 1993. Until this report is received, the Embassy will not entertain any further requests for funding from Mthimba.

6.0 Termination

6.1 Notwithstanding anything contained in this Agreement, the Embassy may at any time by notice in writing, terminate this agreement in whole or in part. In this event, Mthimba shall have no claim against Her Majesty by reason of such termination other than payment of expenses actually incurred under this Agreement to the date of such termination.

7.0 Compliance

7.1 The Embassy may withhold or cancel any or all payments if Mthimba fails to use the Contribution exclusively for the purposes outlined in Article 1.1 above and in accordance with the provisions of this Agreement.

8.0 Budget Review

8.1 If the Embassy is directed to proceed with a reexamination of its budget for' purposes of effecting reductions for specific financial years, this Agreement may be reviewed accordingly.

9.0 Notice

9.1 Any notice to the Embassy or to Mthimba with respect to this Agreement shall be effectively given if delivered or sent by letter, telex or facsimile addressed to the Embassy or to Mthimba at its address as given in this Agreement or other address designated in writing.
