AAF, in line with the resolution passed at the ANC Consultative Conference on 16 December, 1990 did not hold its fund raising event on 24th January, 1991 at the UN. Please inform Barbara Masekela of that fact too. We are also pleased that the LA Conference on the Cultural Boycott has been postponed.

Do you still want the AAF to pursue the possibility of showing the art collection here in New York, that was at Zabalaza (at the Oxford Museum)? There is a strong possibility that the Kenkeleba Gallery would be interested in the show starting September 1991. This is very soon so please advise me who to contact to expedite this. The shipping and insurance of the work would be costly and we would only be able to show the

work here if that were prepaid for in advance. Perhaps the UN Special Committee would pay for it? Wally, what happens to the work afterwards? Would it be possible to sell it here? If so, could a percentage come to the AAF, a percentge to the gallery and a percentage to the artist? That would save the cost of shipping it all
