Telecommunications Policy Forum

Background

The decades of domination of the economy and national infrastructure by minority interests, and the diverting of large measures of resources and manpower into the strategic concerns of providing certain facilities to a privileged minority have passed. The emergence of a new regime has resulted in a political process involving the majority of the population in the determination of priorities in the re-structuring of the economy as well as its direction.

This has meant that new processes and mechanisms have to be put in place to facilitate input from far larger constituencies and interests than previously. In order to cater for this process, and to ensure a democratic development of national priorities in infrastructural development, requires that attention be given to the policies underlying the new decision-making process. This is happening in the communications arena, with the emergence of the telecommunications policy forum.

Definitions

The Telecommunications Policy Forum (TPF) is a dynamic forum of representatives drawn from the entire telecommunications community.

The community is understood as comprising the various players in the field of telecommunications, such as the Telecommunications Operator (Telkom SA) and the broadcasters (SABC, M-NET, Radio 702 etc), alternate telecommunications operators, the proposed regulatory body, the Frequency Spectrum Advisory Committee, various user bodies (such as the NTUG and the LMRA), the private sector suppliers of technology (Industry), consumer bodies representing the general public and the trades unions engaged in the industry.

Objectives of the TPF

The objective of the policy forum will be :

• to provide an open arena for the formulation of proposals on national telecommunications policy,

• to air and address the needs of less privileged communities in the provision

of basic services such as telephony and broadcast services,

to make such recommendations to Codesa and the future government as are necessary for the legislation affecting the telecommunications and broadcast industry,

Composition

The Policy Forum shall be a dynamic body, with no fixed membership, but with a composition defined by the requirements of the issues at hand. It will be managed by a praetorium of no more than eight individuals, representing diverse interests in the community, with no more than one individual representing each constituency. It is envisaged that the Forum would meet as and when required to discuss problems in the administration or legislation concerning telecommunications. For these meetings, invitations to the various communities would be made out, as well as to external bodies such as the economic forum, foreign policy-making bodies or consultants, who would be qualified to make representation on the matters at hand.

Terms of Reference

The TPF would address issues as they arise from time to time, and would be the main recourse for each one of the identified communities to address problems or issues in telecommunications policy. The TPF would be the prime vehicle for ~

The TPF will in itself have no powers of legislation or enforcement, but will be

Nature of the Workshop|

The workshop will comprise three main elements :

)

A presentation session in an auditorium, where a number of papers will be presented, probably 6 at most, outlining the status of a number of issues. Each paper will define the scope of the topic to be dealt with in the workshop, thus limiting the boundaries of the specific issue (topic) to be dealt with.

A working session in which task groups, of a limited size, will debate and reach consensus on a topic. These working groups will be formed from the delegates present, as they prefer. This activity will be spread over two working sessions, the afternoon of the first day, and the morning of the second day.

A review session, presented to the full assembly, in which each task group will present its conclusion and recommendations on the topic. This will conclude the working activities. The forum committee will then compose the Forum Papers into the final output of the working sessions.

Output

A written synopsis of the proceedings will be drawn up by the Forum Working Party, and presented to all delegates at the workshop. This document will also be made available to the public at large.

The document will contain the statement of principle behind each issue from which a standpoint on policy will be formulated. This will prove invaluable to the development of the regulations and the legislation proposed to manage and control this industry.

Benefits to Delegates

Another key result of this workshop will be the interaction between the delegates, which will include key figures in the industry, and in the present Department, and the creation of a dynamic which proves valuable to the development of the industry.

The Film and Broadcasting Forum (FBF) welcomes the agreement reached at Codesa concerning the establishment of an independant authority to regulate the telecommunications sector. However, we believe that other essential aspects concerning the administration of the South African television, film and video industry during the period of transition need to be adressed as a matter of urgency.

The FBF has submitted proposals relating to the restructuring of broadcasting and film to Codesa's Working Group 1 before Codesa 2. These proposals represent the common position of all the major membership-based organisations in the film, video and television industry, reached through a process of intensive deliberations and the consolidation of the different areas of expertise offered by the organisations participating in the FBF. (See Addendum A for participating organisations.)

The FBF believes that the restructuring of film, video and television is of paramount importance for the process of democratisation and development which needs to take place in South Africa and we are most concerned by the way in which these media are currently being administered.

We therefore request an urgent meeting with representatives of Task Group 3 in order to discuss the proposals which were submitted to Working Group 1 previously and to raise our concerns about developments in the field of film and broadcasting.

A FILM AND BROADCAST FORUM CONSENSUS STATEMENT ON THE SOUTH
AFRICAN BROADCASTING CORPORATION

The Film and Broadcasting Forum (FBF) wishes to contribute to the discussions that are being held to determine the future of broadcasting in South Africa. While it is accepted that a new Broadcasting dispensation will take time to be researched and established, a broad dissatisfaction exists amongst all the members of the FBF with the way the SABC fulfils its responsibilities as a Public Service Broadcaster. The FBF, therefore, calls for the immediate formation of an independent regulatory authority that must be charged with the urgent regulation of broadcasting activities, and the coordination of the subsequent restructuring of the industry.

The regulatory authority must oversee and enforce, inter alia :

- * the public accountability of the SABC as well as all other broadcasters

- * an increase in the Production and broadcast of minority cultural and language programming
- increased local programme content in all programme categories

- the elimination of political control of the SABC as the Public Service Broadcaster

- * the creation of a new dispensation whereby community and private enterprise have access to the Nation's broadcast frequencies

In addition, the following matters give cause for concern :

- * Lowest-common-denominator standards are increasingly being adopted by the SABC at the expense of its Public Service responsibility (such as cutting back on African languages)

- * Commercial competition against the private sector from a privileged and publicly subsidised financial base is unacceptable

- * SABC news broadcasts continue to be politically biased

- * SABC's management of public funds

The FRF recommends

- * A moratorium must be placed on the expansion and restructuring of the SABC

- In order to truly represent the broad interests of the South African public, the SABC Board must be reconstituted

The Newspaper Press Union of South Africa (the "NPU") is a voluntary association of some 214 publications throughout the country and broadly represents the printed media in Southern Africa. Naturally the NPU is following with concern and interest the important work being done by Codesa. To the extent that Codesaâ\200\231s task and your committeeâ\200\231s in particular extends to consideration of the role of the printed media in a changing South Africa the NPU would, of course, be anxious to furnish you and Codesa with any necessary information, comment or representations.

Up to the present it has been our understanding that Codesa has only been concerned with the activities of the electronic media in a transitional phase towards a new constitution. However we have noticed that certain political parties and institutions have submitted comment and recommendations also covering the print media.

This letter is addressed to you to seek your assurance and confirmation that Codesa will indeed focus only on the role of the electronic media during an interim phase pending a new

We have word from the Africa Fund Office in N.Y. about your efforts to negotiate the release of political prisoners in your country and move toward a truly democratic government in the New South Africa.

We certainly hope that the 417 political prisoners who remain in S.A.'s jails will soon be released into the community.

We understand that much harassment by the government is going on. In fact that Pretoria is making more political prisoners even as it plays the role of reasonable negotiator. That 854 persons were arrested for political reasons and that 759 have been brought to trial and only 105 found guilty.

We at the Michigan Coalition for Human Rights in Detroit, Michigan remain in solidarity with you, with CODESA, with the ANC in the struggle for justice. Just a few weeks ago we hosted a Mid-West conference: Abolishing Apartheid/Ending Racism. Bethuel Maseramule of NUMSA was here along with many other strong and knowledgeable South Africans.

I am a member of the Southern Africa Committee of the Michigan Coalition for Human Rights. We learned that you are at work trying to negotiate for the release of political prisoners in S. A. and toward a truly democratic government in the New South Africa.

We also understand that not only 417 political prisoners remain in S. A.'S jails but that Pretoria is making more political prisoners even as it plays the role of reasonable negotiator. We have reliable information from the Africa Fund Office in New York that 854 persons were arrested

for political reasons. This brought the year's total to 1,672. Trials have taken place in which 759 were accused and only 105 were convicted. This certainly shows the activity to be based in harassment by the government.

We support your efforts for the release of political prisoners. Keep on: We are in solidarity with you in this long struggle toward a New South Africa with a Constituent government responsible to the majority of the people.
