The African National Congress considers the behaviour and statements of the PAC, both in the run-up and during the Preparatory Conference, to be dishonest, destructive and manipulative.

The PAC has vociferously and repeatedly stated that it will not negotiate with the regime. The ANC has long placed on public record our view that the PAC will participate. This has happened through their attendance at the preparatory meeting. The pattern is clear. For whatever reason, at the public level, the PAC continues with the posture of non-negotiations and walkouts, while using the negotiations the ANC has embarked on as its - vehicle into the process.

It is clear that the PAC came to the Preparatory Conference with a decision to walk out. We have no doubt that this was pure Showmanship, and that they will return to participate in Codesa on 20 December. Furthermore, we are convinced that they will continue to operate in the same way that they started, merely using the forum as a public platform. This stage-management of issues to suit such narrow ends is regretable, especially at a time when it is essential to resolve the grave problems facing our country.

The ANC and the PAC have established consultative mechanisms which include the Patriotic Front liaison committee. We again express our regret that the PAC did not see tit to meaningfully use these channels prior to making infamous allegations against the ANC. It has therefore become necessary for us to place the following on record.

The People Shall Govern!

Given the urgent need to address the serious situation facing our country, the ANC, in the run-up to the Preparatory Meeting, held extensive briefings and consultations. In this process discussions were held with religious leaders, civic organisations, Cosatu, homeland leaders and parties, the Democratic Party, Labour Party, NIC and TIC, the diplomatic corps and other representatives of governments, as well as other formations. Extensive bilateral discussions were held with the PAC itself. The opinions and agreements reached in these consultations guided the ANC in its meetings with the National Party/government, meetings that all those involved, as well as the public at large, knew were taking place. We believe that these were not only essential, but they made possible the successful conclusion of the preparatory meeting.

In our bilateral discussions, both with regard to the Patriotic Front and outside its framework, the PAC endorsed the positions the ANC was putting to the government. Furthermore, the PAC committed itself to certain positions, including that:

t Given their difficulties within the organisation, they would put their position regarding international convenors on the table to satisfy their constituency, but would be willing to accept the consensus proposal of independent convenors.

t Similarly, with regard to the venue, they would merely state their position but undertook to support the proposal for a neutral venue inside the country.

Once again their posturing is clear. A wide gulf exists between their rhetoric and their actions. We experienced similar posturing and manoeuvres both in the preparations and holding of the Patriotic Front. Once again, the decisions of the PF are being distorted. For instance, there was no decision at the PF that the venue would be outside South Africa, or that international figures would convene the conference.

The PAC alleges collusion between the government and the ANC in order to create the perception that they are the true revolutionaries of our country. This is in keeping with their conduct throughout their existence. With this mindset their actions become destructive and self-seeking.

The PAC also requested to accompany the ANC to various meetings with the government. Our response was that it was necessary for them to arrange such meetings for themselves. Therefore, it came as a surprise for us to learn from Minister Kobie Coetsee on Friday at the preparatory meeting, a charge that the PAC did not deny, that there have been repeated secret meetings at the highest level between themselves and the PAC. At press conferences and public meetings the PAC has continued to deny such secret meetings have taken place. However, at a private level, some of their leading oflicials admit that such meetings have been held. We repeat: the ANC has not, and will not, negotiate behind the backs of the people. Our meetings with the government are known to all. Our commitment is to ensure that the people of South Africa, through all their political formations, determine the destiny of this country. The process of consultation and report-backs, both within our own organisation and across the political spectrum, will continue. At our initiative, the preparatory meeting agreed without dissent that all the plenary sessions of Codesa will be open to the media, and we will endeavour to ensure that they are broadcast live, and in full, to the entire nation. As we enter this new and most challenging phase of struggle to achieve a democratic South Africa, we recognise the hopes and fears of all our people lie in our hands. None of us can afford the luxury of clinging to party political interests. It is the national interest that should guide our every action. Anything less is playing with the lives of the people of South Africa.

The time has come for all parties and organisations to deal with problems arising in the way forward on the basis of frank discussions and honest positions. Nothing less will take our country into a future where we can talk of the unity of our people.

Aa Chairman of the Frontline States Ambassadors to the United Nations, my attention was drawn to a press release issued in South Africa by the P.A.C. which referred to a meeting of Frontline Ambassadors addressed by Mr. Thabo Mbeki, Secretary of International Affairs of the A.N.C. With regard to the statement we would like to make the following points:-

- (i) The meeting took place on 20th November, 1991 in keeping with the established tradition where representatives of both the A.N.C. and P.A.C. may request for such a meeting as and when necessary.
- (ii) With regard to the "Minutes" referred to in the press release, it has never been our practice to record minutes of such meetings. Therefore, the so called minutes cannot be of the Frontline States meeting referred to.

(iii) The Frontline States therefore regret the misrepresentations reflected in the so called minutes since these can only result in bringing about disunity within the ranks of the Liberation Movements. A cardinal principle of the Frontline States is to promote unity among the forces fighting against apartheid in order to realise the objective of a non-racial democratic South Africa.

Joint Approach on Constitutional Process

With regard to Negotiations

The Patriotic/United Ftont Conference, held in Durban, South Africa, from October 25-27 1 991

agrees:

1. TRAN5FER QF POWER

The transfer of power from the minority regime to the people is the main objective of our struggle.

In pursuance of this objective an All-Party Conference/Pre-Constituent Assembly Meeting (APC/

PCAM) will have to be convened as soon as possible.

2. PQRPQSE QF THE APg/PCAM

The purpose of the APC/PCAM would be to work out modalities of transferring power to the people. The modalities must centre around the establishment of an elected Constitutional Assembly based on one perSon one vote with all eligible voters voting on a common voters' roll;

constitutional principles within the framework outlined in the UN/OAU Declarations; Inter im

Government/Transitional Authority; the role of the international community; re-incorporat ion of the

Banrustans and a definite timeeframe.

- 3. QQNVENORSHIP
- $3.1\ \mathrm{The}\ \mathrm{APC/PCAM}\ \mathrm{must}$ be convened by an independent and neutral convenor, and not the regime.

The PAC and ANC must agree on an acceptable convenor.

3.2 A meeting should be held within the next few weeks with the regime and other interest ed

parties to discuss the date, venue and an independent convenor for the APC/PCAM.

- 4. APPRQACH TQ PRQQESS
- 4.1 On issues where there is agreement at this or future meetings of the PatriotidUnited Front

actions and positions will be underlined by the principle of unity in action and unity of purpose as

3 Front. On issues where consensus has not been reached endeavours to find common ground will

continue. Should consensus not be reached organisations can act independently.

4.2 The Patriotic/United Front shall be reconvened after six months for the purposes of reporting

and further consultations and joint planning.
