The chairman of the TransPort Committee gave a list of brogerties
under his committee as follows:-
1. Peugeot 504 - (SD393 JM)
2. Isuzu - ( SD 187 IM)
3. CRESEDA - ( SD 313 GM)
The above mentioned vehicles are in working condition and are all
on the road. Thesfollowing are out of order and the faults are
mentioned below
4. Ford Cortina - ( SD 851 DH) - Touch up, painting,
battery and tyres.
5. Peugeot 404 - (SD 797 DM) - Body on fault, tyres
and engine work
6. Land Rover - (SD 902 BM)
The committee has decided that the two vwhicles - Ford Cortina and
Land Rover must be repaired for use in the region. That the
Peugeot 404 must be sold because of its condition.
The chairman of the logistics Cde. Baartman gave a report about
his meeting with the treasurer of the region (Malume) on 10/9/82
