RE: ANC ZAMBIA MISSION STAFF REPATRIATION.

The ANC-SA Mission in the Republic of Zambia Lusaka presents its compliments to your good office and has the honour to inform you that its staff will be repatriating to South Africa in two's for the following three (3) weeks starting from the 20th July, 1992.

The Mission's Administration took this decision due to the fact that the UNHCR Office here in the Republic of Zambia, recently announced that it will stop repatriating people from Zambia after the 3rd August, 1992. They (UNHCR Office) also indicated that the benefits attached to the said repatriation process will also be terminated. (See enclosed circular).

We therefore decided that it will be proper if all the staff members are given a chance to go home and arrange that their next of kins receives the said benefits before they are being terminated by UNHCR. This decision is also sterming from the fact that the staff are not yet receiving their salaries, so the administration saw it necessary that they take advantage of this so as to be able to have something to put away which will help them when they permanently return home.

The Mission, however, also take this opportunity to assure DIA through your kind office that this intended move was thoroughly discussed by the administration and we have made sure that it will not in anyway interfere or disrupt the Mission's functions as it is timed in such a way that when the first group returns, it is only then that the second group will leave and so is the second and the third group. (See enclosed list schedule).

Furthermore, the comrades have been strictly given two (2) weeks to make sure that they introduce their next of kins to the relevant NCCR structure and after which they are expected to report to Lusaka for their duties.

WE have communicated to the TGO, requesting them to provide tickets for returning staff members and also the Repatriation Desk has been informed through Comrade Carol, who will make arrangements with NCCR in order that the comrades are not held up for too long.

We further request that you help the comrades in whatever way you can whilst they are that side.

We hope that your kind office will receive this communication with favourable consideration and response.

Thanking you in advance for your continued support and co-operation.
