He argues that the Finnish . budget, which finally determines the size and scope of the assistance to the ANC(as part of their overall assistance to organisations in South Africa), will only be passed in Parliament in late December or early January and Finnida would not like to make any committments before then. He also indicated that due to the severe economic downturn in Finland the funds for overseas development have been drastically cut back and this will affect all recipients of aid next year. Finnida will formally respond to Our proposal through their Embassy.
- 5. REPATRIATION PROPOSAL. Their Embassy will come back to seek clarification on who exactly will sign the oontrabt with Finnida and is therefore responsible for reporting back. They also want a Clearer picture of how the funds will be disbursed to each student.

Further to our telephone conversations last week and today, please note:

- 1. Doctors' Attachmggt_Program V//
- The problem Finnida had with NCCR has been resolved. Finnida's internal bureacraCy somewhat slaw and NCCR will be informed formally this week by Embassy that the funds are on the way. It is expected that disbursement will take place within the next two weeks. Please inform Ralph.
- 2. Regatriation Progosal: Short term bursaries fogizchoolchildtgg Finnida happy that NCCR will take overall responsibility(as in Doctors' program). Our Repatriation Committee can work out the detailed implementation with NCCR. Finnida also agrees that the excess library funds(297 000 FIM minus QQst of returning archives) can be used for this project by accordingly increasing the number of student beneficiaries. I strongly suggest that the item "pocket money" be renamed "lunch allowance" to satisfy the sensibilities of our friends here. Embassy should be formally informed of all the adjustments, i.e. NCCR will be overall responsible and provide the necessary reportbacks(including financial; full'details of the mechanisms for implementation; h0w many extra students will be catered for; and the change to "lunch allOwance". In fact, NCCR as overall responsible body, shOuld be the agency that communicates all the final details to the Embassy(Finhida is very fUSSy about Such procedural matters). Try to get this done asap because, as you can see from (1), their own bureacracy is not exactly agile.
- 3. Reguest bx_ggst_hfrica Projects_9egt. for two librarians Attached herewith is Zwelahke's letter to FLK7Finnida. Finnida only accepts requests formally endorsed by OTG. Please discuss with Tikly/Mabandla. Although we have made contact with Nonkululeko Woko(Tikly/Mabanla will clarify) we have had no definite response from her as to whether she is prepared to go back to Mazimbu(she is currently in England, having completed her studies). It is the responsibility of the Education Dept. to advise on the status of Cde Nonkululeko. Let me know what the decision is regarding Nonkululeko, Zwelahke's request, and when the request should be implemented, i.e. this year or next year. If this year, then adjustments are needed to the library budget by utilising some of the 297 000 FIM left over, thus once more affecting the budget for the repatriation proposal.
