- 4. Ratification of previous minutes
- 4.1 Noting the fact that many delegates were not in possession of their faxed minutes, the

delegates were given five minutes to study the minutes of the GAC meeting held on $4-6\,\mathrm{May}$.

- 4.2 The minutes of the GAC meeting held on 4 6 May were ratified with the following amendments:
- * Item 7.7 was amended to read "It_was agreed that a discussion on the gender implications of traditional leaders and their participation in CODESA would be incorporated into the agenda of the next meeting of the GAC. In this, regard the delegates were advised to consult their principals on the issue in order to expedite discussion at the next meeting."
- * An error in the spelling of the name of N Jajula (Transkei Government) in Addendum F of the minutes was noted.

Discussion on the Gender Implications of the Issues Raised In Working Group 4

- 5.1 The following documents were distributed or brought to attention of the delegates.
- * The Terms of Reference of Working Group 4
- $a\200\235$ The First Draft Report of Working Group 4 to CODESA 2 (6 May)
- * A written submission from the Democratic Party (addendum B, Item 1) and
- a verbal submission from the National Peopleâ\200\231s Party on the gender implications of the issues raised in Working Group 4
- * A proposed recommendation from the SACP on the application of previous GAC recommendations to the TBVC states until the time of their reincorporation (Addendum C)
- 5.2 The delegates were given thirty minutes to study the document entitled "First Draft Report of

Working Group 4 to CODESA 2", which had been distributed to the delegates that morning.

- 5.3 It was noted that the DP and SACP submissions should be regarded as complementary.
- 5.4 The SACP document was accepted by the GAC as a recommendation to the Management Committee subject to two minor alterations (Addendum D, Item 1.1).
- 55 The DP document was discussed, amended and adopted as_a recommendation to the Management Committee (Addendum D, Items 1.2, 1.3 and 1.4).
- 3.3 Noting that final agreement had not yet been reached in Working Group 4 and that the α

delegates had had little time to study relevant documentation, it was agreed that, at a future

date, should the GAC wish to continue the discussion on the gender implications of the issues

raised in Working Group 4, this option would remain open.

Discussion on the Gender Implications of the Role of Traditional Leaders and their Participation

at the CODESA 2 plenary.;

 $6.1\ \text{It}$ was noted that final decisions on the mode of participation of Traditional Leade rs at

CODESA had not yet been agreed upon.

- 6.2 The GAC agreed on a recommendation regarding the participation of female Traditiona 1 Leaders at the CODESA 2 plenary (Addendum D, Item 2).
- 6.3 The DP presented a proposed recommendation on the issue (Addendum B, Item 2). No agreement was finalized regarding this proposal.
- 6.4 It was proposed that Traditional Leaders should be involved in all CODESA Working G roups, but, to ensure that their unifying role in communities is not compromised, they should

but, to ensure that their unifying role in communities is not compromised, they should not be

part of consensus. No final agreement was reached regarding this proposal.

Working Group 4 had already expressed, in their report, the need to consult with the GAC on certain issues.

Working Group 5 had not yet considered the GAC report

The GAC would meet with the Management Committee within the next 36 hours to asses the incorporation of the GAC report into Working Group reports and to take a decision regarding the status of the $GACa\200\231s$ report to CODESA 2

Minutes of the GAC Meeting held on 4 - 6 May, Addendum F) would be taken as the GAC representatives.

With regards to Item 7.2 above the meeting agreed that M Manzini (ANC) should participa te

in the drafting of the composite report.

With regards to Item 7.1.5 above it was agreed to mandate the $GACa\200\231s$ Steering Committee

to meet with the Management Committee to asses issues concerning the GAC report to CODESA 2.

Noting that the future of the GAC following CODESA 2 was unclear it was agreed that, should the GAC continue after the CODESA 2 plenary, the three representatives of the GAC

at the plenary would coordinate the convening of the next meeting.

It was noted that the two items which were due for discussion under general (refer to i tem $\!\!\!\! 3$

above) had already been dealt with under Item 7 above.
