ANC Press Release on Meeting of the National Executive Committee.
18th July, 1991.

The newly elected National Executive Committee (NEC) of the ANC met in full plenary session on 17th and 18th July in Soweto, Johannesburg.

The meeting, presided over by President Comrade Nelson Mandela, discussed a lengthy agenda which included the following items:

- + evaluation of our recently concluded 48th national conference;
  - + the adoption of a Programme of Action;
- + the Review of Structures at the ANC's Headquarters in Johannesburg;
- + and the election of a National Working Committee consisting of 20 of the elected members of the NEC.

The consensus was that the ANC Conference represented the culmination of a profound democratic process, based in the branches and regions, testifying to the ANC's commitment to democratise not only the country, but also its own structures and inner councils. It posed a challenge to all other political formations in the country to demonstrate in deeds, rather than words, their equal commitment to democratisation.

A Programme of Action, based on three slogans:

Peace, Freedom and the Votel

Jobs, Houses and Education - For All

was also adopted to guide ANC activities in the coming six months. It was agreed that the most challenging task facing he ANC in this period is provide coherent leadership to the South African liberation movement whose goal is the transfer of power to the people by the creation of a non-racial, non-sexist democracy. In addition to building the ANC as powerful liberation movement, rooted among the majority of South Africans, there was a need to project the movement's unbroken record of principled struggle to entrench democratic values among the people of our country and to realise a vision of a single, united South African nation. This vision continues to be an inspiration to millions of South Africans who should be drawn into the ranks of our movement.

The meeting endorsed the decisions of the national conference regarding the setting up of community defence structures and the need to ensure the success of the Church-Business Peace Initiative. The meeting undertook to mobilise the broadest possible support for the national campaign to end the violence.

The NEC noted that despite the efforts of the ANC and other forces sincerely interested in peace, the government had still done little to bring the perpetrators of this violence to justice and had not acted on the demands contained in the AivC's Open Letter to President De Klerk and his Cabinet of April 5th, 1991. A key objective of the ANo during the coming period would be harnessing the efforts of the widest cross section of our people to compel the South African government to clear the remaining obstacles so that genuine negotiations can commence as soon as possible.

In pursuance of this programme the ANC shall mark the following dates:

9th August, South African Women's Day.

27th October, the 20th anniversary of the murder in detention of Comrade Ahmed Timel.

10th December, Human Flighte Day.

16th December, the 30th Anniversary of Umkhonto weSizwe.

## and 8th January 1992, the 80th Anniversary of the ANC.
