PURPOSE:

To make final comuents to the Negotiating Council regarding sensitive areas adjacent to the proposed North West S.P.R.

COMMENTS :

The R.D.A.C. for Region J is of the opinion that the district of Oberholzer should be included in the North West S.P.R. The Golden West Forum, which consists of the various political groupings, local authorities, naine houses, Civic Associations, organised labour, trade and industry, and agriculture have made presentations to Satswa and subsequently to the Commission for the inclusion of Uberholzer in the North West region.

Arguments were based on the following:

- = The major economie =mctivities in the Oberholzer districet are mining and agriculture, like in the Western Transvaal;
- Local aunthoritiass are members of the Western Transvael Association Local Authorities (WESPO);
- Oberholzer falle within the Western Tranavaal region
 of the S.A.P. as well as the education circle for
 Potchefstroon;
- There is a strong trade pattsrn towards Potchefstroon;
- Strong sporting ties exist between Oberholzer and Potchefstroon;
- Inclusion of Oberholzer in the North West region

improves the economic viability of the region.

2.2 Thabazimbi District

- The RDAC appreciates that the inclusion of Thabazimbi in $200\230$ the Northern Transvaal is important for the eccrnomic

viability of the region, bur wishes the smphasize that Thabazimbi was traditionally part of the Western Trangvaal. Strong representation was made by Thabazimbi Town Council, the District Development Association and its constituent members, the mines, as well as the ANC that this area should be re-incorporated as part of the North West region.

The ANC submitted the viewpoint to the Commissionâ\200\231s Technical Committee an 28 September 1983 that the gouthern boundary of the North West region should be the Orange River. This wiewpoint is in line with Satsws Option 1 and can be supported, especially in view of the fact that the remainder of region B may be demarcated to the Western Cape.
