Two boxes were brought over on the charter but inadvertently left at the GOGO Hotel. Kindly retrieve the boxes and distribute copies to those who were invited: embassies, NGO's, Tanzanian Ministries, etc. For purposes of our records, please confirm that this has been done. Copies not required for distribution can be returned to Johannesburg.

#### CONCLUSION

With reference to my fax dated 27/7/92, we expressed willingness at the Joint Working Committee Meeting on 8th July 1992 to give advise and assistance where possible to the future users of the Settlements as regards fundraising. We could provide information on donors who made significant contributions at Mazimbu and Dakawa with capital and running expenditure. Until such time as the Settlements are placed under the respective donor country programmes, donors may be willing to provide emergency funds and we could be of assistance here by introducing the relevant Tanzanian Ministry to donors, particularly NGO's in Sweden, Norway, Denmark, Finland, Holland and Italy. It is possible that these would provide some assistance with running costs in the transitional period and probably in the long-term. It may be necessary for representatives of the Tanzanian Government and the ANC to undertake a mission to these countries to facilitate fundraising. If there is interest in this type of collaboration, we could prepare a proposal for submission to key donors. Informally, an Embassy official and a Government official expressed the need for such collaboration. In my fax of 27/7/92 I proposed that this be raised in the JWC.

The Tanzanian Government, donors and the ANC have expressed the desirability of South African students going to Tanzania to study in the new institutions at Mazimbu and Dakawa in the future. Norway and Finland, for instance, will be happy to consider funding proposals that will enable South African students to train at the VTC at Dakawa. Close coordination will be required. with. the relevant authorities of the new institutions and here in South Africa a coordinating mechanism will have to be established to administer a programme of this nature. We propose that this matter be raised in the JWC to obtain agreement in principle and to seek guidance as to implementation. Here in Johannesburg, the matter will be placed before the Departments of Education and Human Resources.

We hope you will be able to respond swiftly to this Memorandum to effect the implementation of the tasks raised under the three sections above.
