Dear Mr. Msimang,

Subject: ANC/82/002 - Chemicals, Reagents and Laboratory Equipment for SOMAFCO.

Please refer to my letters of even reference dated 28/2/1983, 16 March 1983, 8 April 1983 addressed to our Headquarters and copied to you on the above-mentioned subject.

In this connection, I note that several consignments of chemicals have been shipped, forwarded and notified to you for collection on arrival as indicated in my letters dated 4/7/1983, 2 August 1983 and 3 August 1983 respectively.

While forwarding a copy of your letter dated 5/11/83 on the same subject, I am wondering whether it is possible to sort out what has actually been received of the original request and what is still in the pipeline, if any. We seem to be in danger of duplicating the materials ordered for SOMAFCO in the absence of detailed lists of deliveries received to-date.

You are aware that your request dated 16 August 1983 enclosing a purchase list from Griffin and George worth more than the total budgetary provision of US \$ 50,000 for expendable and non-expendable equipment in 1983 was forwarded to Mr. Mustakim under cover of our letter dated 17 August 1983. It might, however, be difficult for our headquarters to trim down your order to the balance available in budget lines 41 and 42.

Ideally, you need a consultant or two (i.e. an experienced Science teacher for 'O' level Science and/or a laboratory technician) to identify SOMAFCO's real needs from the list offered by Griffing and George as a commercial firm. Unfortunately, the science laboratories at SOMAFCO are not yet ready for assembling and storing most of the equipment and chemicals already ordered.

Please let me have your reaction to my suggestions and observations regarding your letter of 5 November 1983...
