
Dear Cde Ruth

SPONSOR'S REPORT OF ANC STUDENT SISA NCWANA

1 BACKGROUND

Sisa Ncwana came to Finland on October 1985 by decision made by Developing Country Association of the Coalition Party. It was agreed with ANC Scandinavian Mission on giving to Ncwana a three-years-scholarship to study economics in Finland.

First Ncwana stayed in Viittakivi-Institute to learn some Finnish language and then he moved to Tampere in order to study economics at the University of Tampere.

2 NCWANA'S STUDIES AT TAMPERE UNIVERSITY

Ncwana took courses on economics and business administration. His ability to speak or write in Finnish was not very good and that caused some problems with his studies.

His success with his studies on sponsor's view wasn't very good one. During two terms he passed only few exams and took courses on basic level of economics and business administration.

Ncwana complained that the whole system at Tampere University was not very good one and he wanted to move to Helsinki.

3 NCWANA'S STAYING IN HELSINKI

Ncwana moved to Helsinki during summer 1987 by his own decision. He didn't contact his sponsors before doing that. One reason was that secretary of Developing Country Association, Ms. Tuula Syrjälä, was spending her holidays abroad and Ncwana couldn't get touch with her.

He organized his living in Helsinki by himself, he rented a flat in a student house in Helsinki. He wanted to start studies at the Helsinki School of Economics (HSE).

At the very same time the secretary of Developing Country Association changed. Ms. Syrjälä was succeeded by Ms. Anne Palm-Perälä. That caused some problems with taking care of Ncwana.

Ncwana didn't get any permission to study at the Helsinki School of Economics - mainly because his short knowledge on Finnish language - until January 1988. That means that he didn't study at all during the autumn term.

At the beginning of 1988 he was qualified to take few courses at the HSE in business administration. He wanted also to study marketing but so far he has been disqualified. He was permitted to study business economics for 20 so called "studying weeks" which means for a Finnish student about half a year's studies. In order to get a master's degree you need some 160 studying weeks.

He was studying quite hard in the beginning this year. Unfortunately the situation right now is not so good.

4

FINANCIAL MATTERS

Ncwana has got the normal allowance which means 2.200 Finnish marks per one month. The sponsors have also paid his rent (FIM 323 per month).

He also has got some extra allowances (FIM 200-500) especially before Christmas and summer holidays.

He has not been very careful with his financial matters. He has been loaning money from different people and many times the sponsor has had to pay them back. There were problems during the last autumn with the payments from the sponsors side which caused some problems to Ncwana. But it seems to be so that the allowance has not been enough to Ncwana and he is lacking money every now and then.

POLITICAL MATTERS

Ncwana has been travelling through whole Finland giving lectures and speeches about the situation on South Africa and introducing the aims and work of ANC. He has done that job very well. People have liked him and given a lot of attention to what he has been saying.

On sponsor's view he has represented ANC very well and promoted the ANC aims.

As it was mentioned earlier, Ncwana's scholarship runs to the end next autumn. The Developing Country Association has made a formal decision to finish Ncwana's sponsoring from 1st of October 1988.


We are ready and willing to discuss with the representatives of ANC of the settlement of Ncwana's leaving.

LOUISAH NCWANA

Louisah Ncwana arrived in Finland in November 1986, and began to study the Finnish language at Viittakivi Folk High School. She continued her studies at the University of Helsinki, and privately in June 1987. Louisah Ncwana participated in summer 1987 in courses of photography and journalism in two folk high schools, practised at a newspaper (Kansan Uutiset) for two weeks, and began a communication course at Sirola Institute on September 12, 1987. Simultaneously she began her first course at the University of Tampere (to be carried out in writing).

In fall 1986 Louisah Ncwana had mental difficulties, which reflected in her health. Her condition improved in spring 1987, and thereafter she has studied efficiently and managed very well. She has also written about the situation of ANC women and children in several papers, and spoken on these topics in various events.

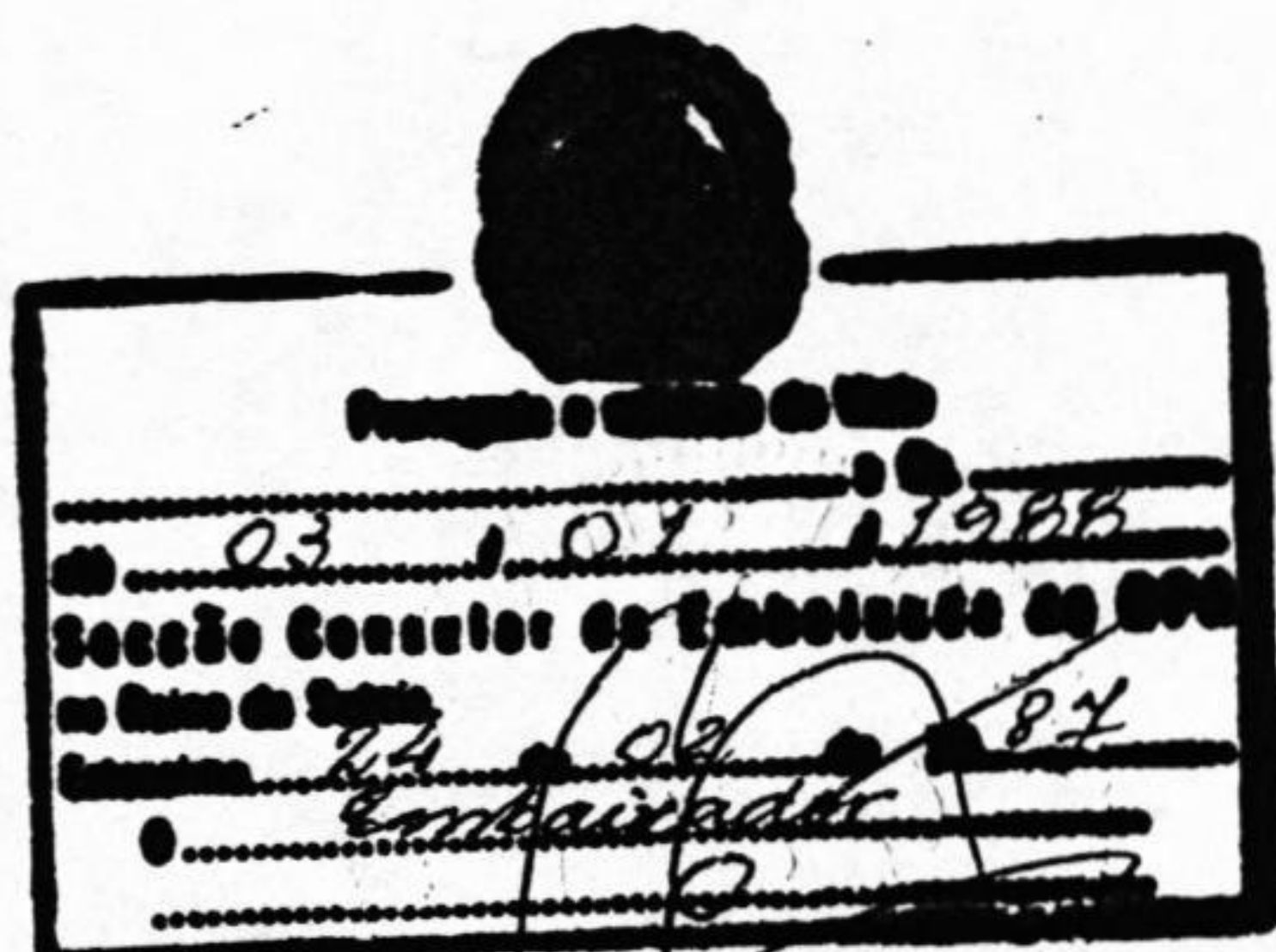

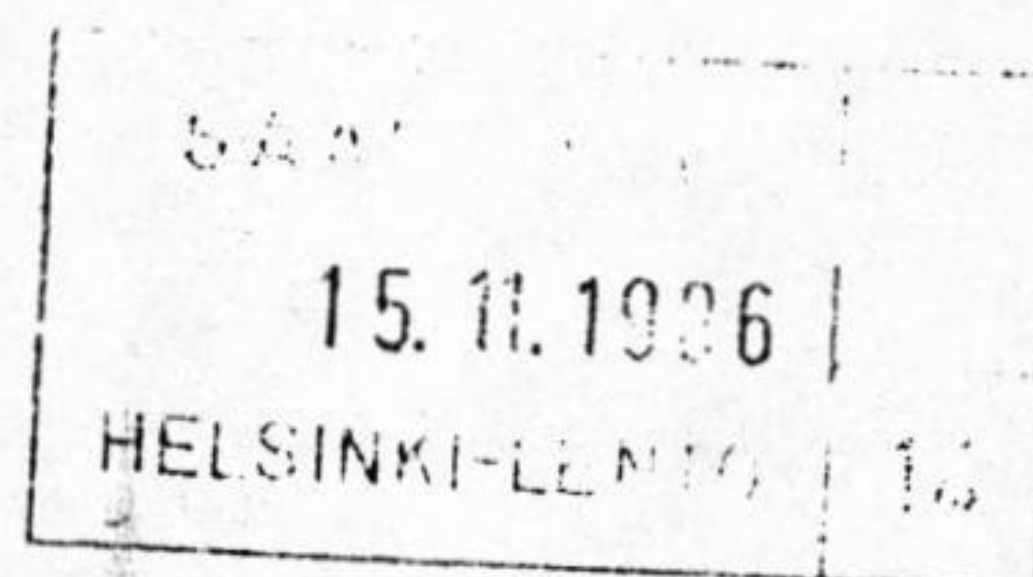
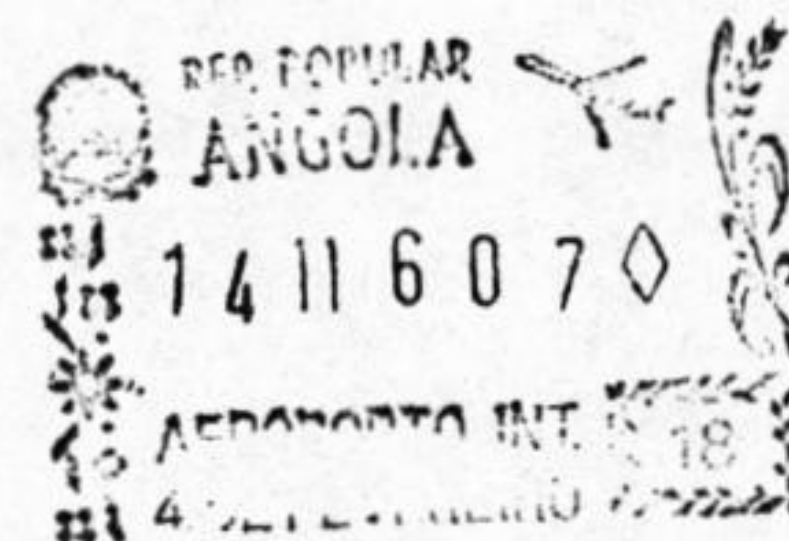
