CONDITIONS OF ISSUE

The travel document is valid only for the country/countries and period/periods mentioned in the endorsements of pages 5 to 21. After a period of six years from the date of issue the validity of the travel document expires finally. The document must then be returned to the office where it was issued.

The travel document remains the property of the Government of the Republic of South Africa and he amended, withdrawn or cancelled at any time at the (f)leas. the Minister of Home Affairs on behalf of the said Government, and shall, upon the request of the said Minister or an authorised thereto by him be forthwith surrendered by the bearer; - to the said Government.

If the travel document is found in the possession of an unauthorised person, or is mutilated, in any way or if any amendment, endorsement or addition is made by any person other than a duly authorised official, it is liable to be impounded.

The travel document must be produced on demand to the authorised officer at the place of departure from and return to the Republic of South Africa or the Territory of South-West Africa.

INFORMATION

The travel document does not exempt the bearer from compliance with the immigration or customs laws or ordinances in force in any area to which the bearer is authorised to travel.

This document is valuable and should not be allowed to pass into the possession of an unauthorised person. If the document is lost or destroyed, the bearer should be reported immediately to the nearest Commissioner or to the Department of Co-operation and Development, Pretoria, or to the South African representative of the country in which the bearer happens to be and to the local Police authorities. A new travel document can only be issued in such cases after exhaustive inquiries.
