We are arranging this Study Conference because we believe that international pressure has a vital role to play in bringing to an end the apartheid regime in South Africa. Certain forms have already been used with some effect, but none of these official condemnations or resolutions have brought any relief to those suffering under apartheid.

Sporadic and limited boycotts have taken place in response to calls from African and other leaders within South Africa. These have given substantial encouragement to those opposing apartheid, but how effective have they been as a political weapon? What problems do they create for the boycotting countries? And what are the consequences of a far wider and more effective policy of economic sanctions? In view of the enormous problems involved, we believe that a useful purpose will be served by a careful and sympathetic study of this whole question.
