early January. We are in the process of preparing a detailed proposal on the education and training programme to be sponsored by INTERSOLID in 1994, as you require. For the purpose of clarity of communication, can I suggest that we refer to the first programme (from July 1993 to July 1994) as Programge A, and the new programme in 1994 for which we are compiling a proposal, as Programme 5. I think that this classification will be in the mutual interests of both INTERSOLID and the Batlagae Trust, especially as far as the writing of progress reports is concerned. With regard to Programme 11, I would like to confirm that we will have utilised the entire amount of R67 500 by April 1994. In your letter you mention that INTERSOLID prepares all of its reports to ITNNIDA

If it will suit you better, the Batlagae Trust will be able to submit an interim progress report on Programme A by the end of March 1994, and a final report on Programme A by the end of August or early September 1994.

As far as our proposal to INTERSOLID requesting support for Programme B in 1994 is concerned, I need to clarify a few issues. As I understand your letter of 25 November, you would like Programme B to be similar in nature, duration and value as that of Programme A. With regard to the amount of funds that Intersolid will be prepared to provide for the new programme in 1994, I refer to your letter of August 24 to Mzwandile Mbangula in which you stated that an amount of R80 000 had been approved by INTERSOLID's Board of Directors for a new education and training programme. Will it therefore be in order if we request INTERSOLID to contribute R80 000 towards programme B in 1994? 2/....
