1.1 REGIONAL REPORT:

Mathole gave a brief report on the May 19 workshop, and 2 June launch Rally. Khumo gave report on subsequent events following the Launchi - A lot of interest shown by individuals from local structures. People are encouraged to inform communities about the NCCR and list of contact is being drawn as poeple come. SAYCO PIONEER'S group has taken keen interst and a workshop has been organised where the NCCR will be discussed 1 etail. Request from service organisation for NCCR speakers al 0 indicate people's interest.

1.2 NATIONAL:

Khumo explained the role she plays as secretary for the conveners and informed the house that she is in contact with regions. Some regions are reported to be doing well while some' need some attention and assistance. Concern was raised on the delegation trips to regions without proper consultation with the conveners. A reason given for the miscommunication was accepted. Western Cape.

B.M. explained that the problem of the extend of the participation of service orgainsations had raised problems in the region. She fortunately gave an input that put the NCCR in its proper percpective and explained that the programme is an ANC initiative and is meant for structures within the Mass Democratic Movement primarily.
