6 May

7 May

09h00 Rainer Funke, MP: Social Market Economy in the Federal Republic of Germany- from the view point of a banker and parliamentarian

Focus on the structure of the South African economy with specific reference to the de jure and de facto exclusion of black South Africans from the economy.

Input will be made by speakers representing business, trade unions, academia and the ANC (the contributions will not be exhaustive. The emphasis will be on discussion and debate. However, supporting material which could be available for delegates will be very welcome).

14h30 The structure of the South African Economy:

Restraints and challenges facing South Africa in the 1990s.

8 May

09h00 Nationalisation

The case for and against nationalisation in South Africa. Input will be made by a cross-section of delegates.





14h30 Papers by West German and Swedish economists as to their respective systems. Focus will be on how their countries' economies endeavour to maintain economic growth with justice.

9 May

09h00 Options for the Future

Specific examples of how to address historic grievances and how to include all South Africans in a future post-apartheid economy.

The focus will be on concrete, positive and practical steps which can be taken now. All delegates should come prepared to offer suggestions for action.

17h00 Conference ends
