- ii) Cde. Dan O'Meara's keynote address on sanctions took a position at variance with the ANC's

Response: The conference was convened by the Canadian COuncil for International Cooperation. The ANC was not invited to co-organise the event. However, if invited, we only serve on consultative basis.

Cde. Dan's remarks were personal and do not reflect the position of the ANC

Cde. Dee September's letter re: awaiting formal approval of five applicatants belonging to the Manitoba Unit.

Response: Membership approved and this was communicated to the unit.

Toronto office has nothing to do with the WIDF conference in Moscow. The National WOmen's Secretariat is handling the matter. ANC Canada is not sending any delegates.

Manitoba Unit minutes of Feb. 8/87 acknowledged.

- 4. <u>Scholarship</u> application received from Zeenat Saloojee was discussed and RPC recommended applicant to Dept. of Education after considering the following:-
- a) participation of the applicant in the Movement;
- b) suitability, willingness to serve the Movement.
- 5. $\underline{\text{Taks of the RPC}}$ Draw up a two part document Part I to consist of tasks already set up by HQ. PArt II should relate to regional conditions in our case Canadian.

The Chief Rep., Political Commissar and RPC Secretary are to prepare the document and present it to the RPC for approval.

- 6. <u>Child Care</u> RPC recommended to Finance Committee that it makes funds available for child care whenever there are ANC functions.
- 7. Visit of President O.R. Tambo to Canada may take place in the latter part of May, 1987.
- 8. <u>General</u> a) Concern was raised about the absence of the ANC in the U. of Toronto and the black community. It was suggested that key people in the black community be sounded out on the matter. This would address BCM/PAC activities in said community.
- b) Absence of Chief Rep: In his absence, the Chief Rep. is empowered to assign a member of his choice to act on his behalf.

c) Montreal meeting of CSAA

Both ANC and BCM invited to the event. Since our policy is never to share a platform with BCM/PAC, Cdes. Cecil Abrahams and Neo Rathebe breached this policy despite advice from RPC not to do so. The matter is being pursued with both.

Henceforth, the ANC should seek a programmbefore committing itself to a meeting, conference, seminar, etc.. This is to guard against possibility of appearing on same program with BCM/PAC.

- 2. Matters arising: Official response from the RPC to Cde. Randeree's speech (75th Anniversary address to the Manitoba Legislature) still outstanding.
- 1(b) Minutes of the 17th February meeting were also read and adopted.
- 2(b) Matters arising: The ANC has withdrawn from the upcoming (March 27, 1987) Toronto Board of Education conference on Apartheid because of PAC/BCM participation. This is in line with our stated policy of not sharing a platform with these groups. All units are advised to observe this position.

In the light of the above, it was suggested that the Chief Rep. and Pol. COmmissar draw up a draft document on Discipline(to be sent to H.Q. for approval) regarding:

a) individual members' links with BCM/PAC elements;

- b) recruitment of students who are Black Consciousness inclined but amen∰able to the Freedom Charter.
- 3. <u>SOMAFCO application</u>: In the past, the Chief Rep. and Education Committee have processed applications for SOMAFCO. but in the absence of an Education Committee, the Chief Rep. has had to perform this task alone. It is suggested that the RPC attend to such applications and make the necessary recommendations to the Education Secretary in H.Q.
- Cde. Raymond Leitch's application kit came before the RPC, but was not fully dealt with as he has not furnished a political report. Once such a document is made available, the Chief Rep. and Pol. Commissar will meet with the applicant, after which the matter will be referred to the RPC.
- 4. <u>Membership application</u>: One has been received from Michael Herman. The Pol. Commissar will be sending him literature and arranging a meeting between the RPC and the applicant.

Since membership forms lack a section on "Political Background" a questionnaire will be drawn up to augment the forms.

- 5. Tasks of the RPC: The item has been deferred to the next RPC meeting.
- 6. <u>International Report</u>: This is to be made availabe to all units. The report is strictly an internal document, and is in no way to be made public.
- 7. Youth: Moves are underway to revitalize the Youth section. Already one meeting attended by 8 members has been held. It is intended to have the Chief Rep. and Pol. Commissar at the next Youth meeting to advise on strategy and guidelines.

Parents (i.e. those who are ANC members) are encouraged to get their chidren involved in our structures e.g. Youth Section, Masupatsela. The issue will be brought up at the next unit meeting.

8. Extended RPC meeting: The weekend of May 30 and 31st, 1987 has been suggested with delegates arriving on May 29 or earlier.

Units are requested to submit items for the agenda. There will be no limit to the number of delegates that can attend. As such units are urged to include members of Youth and WOmen's sections in their delegations so as to make conference broadly representative of our structures.

- 1. Minutes of May 11 were read and adopted.
- 2. Matters arising: Neo: The political commissar had arranged a meeting with Neo, but the latter in line with previous actions, failed to attend. Letter to be written to Neo one more time inviting him to meet with the RPC. Response expected in 30 days, otherwise action will be taken against him.
- 3. Comrade Dan O' Meara's letter was formally discussed by the RPC. It was decided to send for Comrade Dan's paper and taped speech to clarify the matter re: position on sanctions issue.

A copy of the above-mentioned letter will be forwarded to Cde. Randeree with a follow-up on the issue.

Minutes (May 12/87) of the Vancouver unit were acknowledged. A question raised in the minutes was Cde. Kitty's participation in the upcoming 2nd ANC Women's Conference.

Response: as an elected member of the National Women's Secretariat, Cde. Kitty has been nominated to attend the Conference.

4. <u>Parallel Conference:</u> Chief Rep. has received a copy of a letter from Cde. Karenza addressed to the International Department re: Parallel Conference and ANC participation. It was resolved to: -write to the International Dept. giving background information on the conference organization and the terms under which ANC is prepared to participate. Task to be undertaken by CR.

- write to units to reinforce ANC position (See extended RPC Minutes and covering letter to units) $\,$
- seek further clarification from conference organisers other than Karenza.
- 5. Francophone Conference: To be held in Quebec City on Sept. 2-4, 1987.

 NGO's are organising a seminar on Southern Africa.

 ANC invited to an event entitled Mandela '87 to be held in Montreal on 10th October. E vent co-organised by the City of Montreal and NGO's at which time a street will be named after Cmdes. Nelson and Winnie Mandela. An evening of culture will follow. "Leading figures" of the ANC on their way to the Commonwealth Conference in Vancouver are invited to attend the Montreal ceremonies as honorary guests of the City.
- 6. <u>Visit of the President</u>: The Prime Minister's Office has indicated that the Prime Minister will be available for a meeting on 16th or 17th September, 1987. Not clear whether the President will be here for 2 or 5 working days. We are proposing the latter.
- 7. <u>Black Education Trust Fund</u>: Canadian Government has allocated funds for black education \$2 million seed money. Originally the ANC had been invited to attend the conference, but the invitation was withdrawn for political reasons.
 - Trust Fund is to be established in September, 1987
 - there will be consultation with the NECC
 - scholarship will be available to South Africans in Neighbouring countries.
- 8. <u>General:</u> Cde. Randeree's telephone conversation with Sam (complained about late delivery of ANC material) brought before RPC. Conversation ruled unprocedural. Cde. Randeree should have talked with DIP. However, the latter will pursue the matter with Randeree.

<u>Membership</u>: new format will be brought before the next RPC meeting.
- applications lying in the office and not sent to HQ on time. We owe the individuals concerned an apology.

 $\underline{\text{Office Committee}}$: Duties and areas of responsibility delineated.

<u>Mail Collection</u>: contention about who collects mail. Originally agreed that Cde. Simon will collect mail. But CR later recanted arguing for his continued collection of mail as he has done for the past 15 years.

Office Staff's argument: Cr has more pressing matters to attend to. Therefore mail collection should not be his responsibility.
