Contract between the "Stichting voor het Nieuwe Zuid-Afrika"  
and the African National Congress for Projectnumber NZA 2010.

The Stichting voor het Nieuwe Zuid-Afrika hereby legally represented by

K. Groenveld and J. Mulder

hereafter referred to as "de Stichting"

and the African National Congress hereby legally represented by

M. Msimang

hereafter referred to as "ANC"

have the intention of signing this contract for the implementation of  
projectnumber NZA 2010 of de Stichting.

date of application	: December 1999
starting date of the project	: February 2000
date of completion	: October 2000

The ANC aims to implement the proposal and has agreed to contribute to the  
implementation of the project.

Both parties agree to the following:

- 1) De Stichting and the ANC shall co-operate in the implementation of the  
project in accordance with the content of the document "Funding  
Application for Projects in 2000" of the Commission for Religious Affairs.
- 2) De Stichting will pay an amount of Nlg. 276.840,-- (two hundred seventy  
six thousand eight hundred and forty Dutch guilders) to the ANC in order  
to implement the contract. An amount of Nlg. 100.000,-- will be  
transferred upon signing of the contract. An amount of Nlg. 100.000,-- will  
be transferred 15 May 2000. An amount of Nlg. 76.840,-- will be  
transferred 15 August 2000. The second and third tranche will be  
transferred after receiving an interim report describing the implementation  
of the project (see article 4 of the Contract) by the Stichting.
- 3) The ANC will execute the project in conformity with the Contract Project  
document including the budget.  
If substantial deviations occur the ANC will consult de Stichting in  
advance. Projectactivities executed after 31 December 2000 will not be  
financed from the contribution of NZA.

## 4) Conditions for reporting:

The ANC will provide an interim report 1 May 2000 and 1 August 2000 describing the implementation of the project including a comparison with the intentions described in the Contract Project document. The interim report will include an overview of the expenditures.

The ANC will provide a final report within two months after completion of the total project.

The report will take form of:

- a) a financial report including a comparison between the budget and real cost.

An auditor's opinion to the final financial report will be required as well;

- b) a report describing the implementation of the project involving a comparison to the intentions in the Contract Project document.

5) Conditions for monitoring and evaluation:

If de Stichting deems so necessary it may enter into a review of the project at any time during the implementation of the project until one year after the date of completion (see above). This review will be carried out by representatives of de Stichting. De Stichting may if it so chooses enter into negotiations with the ANC about the composition of the review team. The ANC will provide co-operation to such a review exercise.

- 6) De Stichting may terminate funding the programme and thereby this contract without involving a court decision, if de Stichting has sufficient ground to assume that the ANC is no longer capable of implementing the project according to the agreed documents or if de Stichting gains the impression for whatever reason that its funding will not achieve the objectives that were intended when it entered into this contract.

- 7) This contract takes effect on the day that de Stichting will possess a copy of this contract legally signed by the ANC.  
This contract is invalidated on the day de Stichting explicitly agrees with the final report by the ANC dealt with in article 4.

- 8) As appendices are attached the following documents which are to be considered integral parts of this contract:

- a) The Contract Project document;
- b) The arrangement for the transfer of the contribution by de Stichting.





- 9) The ANC has taken due notice of the policy paper of de Stichting. The ANC endorses the main criteria of de Stichting:
- The principle of building national unity and fostering national reconciliation. This precludes the ideology of racial or ethnic exclusivity, as well as incitement to racial or ethnic hatred.
  - The principle of managing political differences through peaceful competition and dialogue. This precludes advocacy of or resort to violence as a political tool.
  - The principle of participation in free and fair elections. This entails acceptance of the mechanism of free and fair elections as the only legitimate means of apportioning political power.
  - The principle of participation in the institutions of parliamentary democracy. This entails a commitment to participation in the principal democratic mechanism of popular representation and law-making, which is parliament.
  - The principle of democratic tolerance. This requires mutual tolerance and respect for competing political views and formations.
- The ANC complies with the Electoral Code of Conduct.
