THIS WORKSHOP OF THE SOUTH AFRICAN HINDU MAHA SABHA HELD IN DURBAN ON SUNDAY,

2ND FEBRUARY 1992 REITERATES ITS ADHERENCE TO ARTICLE 18 OF THE UNIVERSAL DECLARATION OF HUMAN RIGHTS WHICH ENSHRINES THE RIGHT TO FREEDOM OF THOUGHT, CONSCIENCE AND RELIGION AND THE FREEDOM IN PUBLIC OR PRIVATE, TO MANIFEST HIS RELIGION OR BELIEF IN TEACHING, PRACTICE, WORSHIP AND OBSERVANCE;

IT NOTES THE RECOMMENDATIONS OF THE NATIONAL INTER-FAITH $\hat{a}\200\230$ CONFERENCE ON RELIGIO N -

STATE RELATIONS HELD IN JOHANNESBURG FROM 2ND - 4TH DECEMBER 1990 WHERE IT WAS DECLARED THAT SOCIETY SHOULD MOVE FROM A POLITICAL CLIMATE OF CONFLICT TO A CLIMATE AND PERIOD OF RECONCILIATION AND IN WHICH THE FREEDOM OF RELIGIOUS BELIEF AND ASSOCIATED PRACTICES WITHIN A JUST DEMOCRATIC SOCIETY SHOULD BE GUARANTEED IN A JUSTICIABLE BILL OF RIGHTS ENSHRINED IN A NEW CONSTITUTION FOR A NON-RACIAL, NON-SEXIST DEMOCRATIC AND JUST SOUTH AFRICA.

THIS WORKSHOP FURTHER AGREES THAT EVERY INDIVIDUAL WHILST HAVING THE RIGHT TO FREEDOM OF RELIGIOUS CONSCIENCE, DOES NOT HAVE THE RIGHT TO VILLIFY OR RIDICULE ANOTHER PERSON'S RELIGION AND PRACTICES.

THIS WORKSHOP RESOLVES TO RECOMMEND THE ELECTION OF A RELIGIOUS FREEDOM CONTINUING COMMITTEE OF THE HINDU FAITH TO PARTICIPATE IN DISCUSSIONS AND FORUMS ORGANISED BY

OTHER GROUPS WITH A VIEW TO PUTTING FORWARD ITS DECISIONS AND PERCEPTIONS IN SUCH FORUMS SO THAT ULTIMATELY ITS WIEWS WOULD BE REFLECTED IN THE NEW SOUTH AFRICA, ITS CONSTITUTION AND BILL OF RIGHTS AND THAT THIS COMMITTEE SHOULD INCLUDE REPRESENTATIVES OF OUR WOMEN AND YOUTH.

THIS WORKSHOP AGREES AND ADVOCATES THAT IN THE NEW SOUTH AFRICA AN UNDERSTANDING

AND TOLERANCE OF ALL RELIGIONS MUST BE CULTIVATED, AND ALL RELIGIONS AND RELIGIOUS PRACTICES MUST BE PROTECTED FROM SLANDER AND THAT TIME SHOULD BE PROVIDED IN THE SCHOOL CURRICULUM FOR RELIGIOUS TEACHINGS OF OUR CHILDREN WITHOUT BIAS OR FAVOUR.
