3. OBLIGATION OF ANC

- 3.2 26 825.020.00 shall cover all expenses related to the students schooling such as school fees, exam fees, book allowance and a onthly stipend for 70 students for the period of January fecember 1982, follow-up from the ANC, Regional Education office in Harare, and coordination and control by NPA, Harare according to approved budget.
- 3.3 ANC shall instruct the ANC regional office in Harare to carry out the following duties so the programme can run smoothly. The responsibilities of the ANC in Harare are as follows:
- Provide list of expenditures in the beginning of each month not later than 10th every month to give NPA-Harare the sufficient time to issue the necessary cheques and make payments to the individual student.

Collect all cheques issued to individuals and distribute these accordingly, and see to it that the students sign for the cheques. Is responsible to follow up the students in this programme on a regular basis and to familiarise itself with the studens performance at school and other problems relating to their schooling.

- Inform NPA-Harare immediately if there are any drop outs in the programme or changes to revise the programme accordingly,
- Shall give a progress report after each term of the students of which One copy is sent to ANC, Head office in Johannesburg and one copy to NPA-Harare for consideration.

4. OBLIGATION

NPA shall be responsible for all funds that are made available for the programme. NPA Regional office in Harare shall be the - executing body of NPA and shall carry out the following duties. ${\tt x}$, J

- keep proper records of all funds received from ANC to the programme.
- pay timeously school fees and exam fees directly to the various institutions that have been admitted in the programme.
- issue cheques in the name of the individual student on a monthly basis to be collected by the Regional Education Officer in Harare for distribution. The cheques shall be made available to the education officer not later than 15th of every month.
- provide financial statement and progress report after each term.
- provide annual report and audited accounts by a chartered accountant to be submitted with one copy to ANC Head office in Johannesburg, one copy to ANC Harare Office and one copy to NPA Head office in Oslo, not later than 15th February 1993.

- liaise with ANC Harare on all issues pertaining the programme 5. EN RAL NDITI N $\,$

If aisituation of contract termination occurs during the course of the contract period, the balance shall revert to ANC. Similarly in the event of misappropriation of funds or use of funds which is not in accordance with the agreement during administration of this programme by NPA, the funds including accumulated interests, sh'gllvrevert to ANC.

In case of dispute, the two parties shall attempt to resolve the . situation on basis of mutual consultation and/or by and independent arbitrator agreed upon by ANC and NPA with this contract and annexes I, II and ill as the proper document for reference.
