1991, considered reports from our own structures. the ANC. and the SACP
about the current violence and a planned offensive timed to coincide with
our May Day rallies, and leading up to the May 9 ultimatum of the ANC.
The assessment of the CEC was that the state is directly involved in various
ways in orchestrating this violence, and that employers share nesponsibility
for their failiure to bring pnessure to bear to end the violence against their
own workers.
The CEC was unanimous that decisive and radical action was needed to put
an and to thie coneoioee carnage. Score: of COSATU mcmbcrs and their
families have died or been injured in this violence. The violence has not
