

MINUTES OF THE MANAGEMENT COMMITTEE MEETING

HELD ON THE 26 AUGUST, 1991.

Starting Time 09:15 hours

Cde Isaac Makopo - Chairman, Cdes Kenneth Kotelo, Bizzah Legobye, Zwelakhe Mankanzana, Fenny Dlamini, Sasha Kani, Don Ngakane, Mpho Keagile, Moffat Monakgotla, Jackie Morake and Pule Tsatsi.

At the start of the meeting, the chairperson of the meeting proposed that a secretary be appointed by the house so that minutes can be made available at all seatings when required. Then, the house suggested that it should be someone from the Director's office; and the name of Cde Sasha Kani was recommended and that he be assisted by Cde Moffat Monakgotla.

Minutes of the previous meeting were maped out by Cde Makopo, as there was no proper record, kept of those minutes. But over and above the maping was passed as true reference by the house and the proceedings became normal.

The discussion related to the above map-up was on the emergency meeting held on the 02 August, 1991.

Cde Pule Tsatsi, distributed minutes taken by him on the 12 August 1991, which were red to the house by the Chairman of the day Cde I. Makepo, and topical issues as per agenda were passed as a true record and further discussion insued due to their nature, where necessary actions were recommended such as the E.O.C. matters, as whether it should go on as an institution of learning and that now that the Principal, who has been abroad is back should be accorded his position, then the house agreed that he should proceed with his duties as a Principal. A letter was to be arranged from the directorate of both settlements - Dakawa and Mazimbu to that effect.

The question of E.O.C. was the most important one, it was still requested that the V.T.C. occupation of the E.O.C. premises should be left until repatriation takes place as there is no proper accommodation for those who will have to vacate the premises, and for they are not prepared to part of the instutionalized comrades.

ADULT EDUCATION ^

The house nomited the following comrades to head the adult education set-up.

a) Tweed Mathe - Principal; b) Openheimer, c) S. Pitso, d) Fenny Dlamini, e) Ben Sechaba and f) Mompati were suggested to assist. The ex-officio members are Cdes Isaac Makopo, Kenneth Kotelo and Pule Tsatsi.

Once more like other previous meeting the question of candidates for the adult education was raised and this was also related to the other skills such as Tie andDye, Soap making etc.

People from Charleston, who were said to be the students were actually not forth coming as was said before and that some were not eager to learn.

On Cdes Nzoyiya and Openheimer, the house said these comrades can be recruited to teach at SOMAFCOSecondary or join the adult education when E.O.C. is taken by V.T.C. later on.

The Nigerian architech has been joined by her husband who is also willing to assist in teaching at V.T.C.

CHILDREN REPATRIATED TO ZAMBIA

The house suggested that a review of remaining children as per roll be done, so that if need be some teachers at the primary school can be rectruited to the adult education.

AUSTALIAN FUNDED PROJECT .

The proposed Australian project which was supposed to have taken place sometime ago was still not forth coming due to certain unmentioned points which were to be sent to the Task Force.

SOMAFCO

The Secondary School teachers suggested in a meeting which was held at Somafco that some of the Form III students be given a chance to write an assessment test, which when passed they can join the Form IV classes.

The matter was approved between the Principal and the teachers with the blessings of the Director of Schools Cde Makopo pending on the out come and their hal yearly examination and performance.

VISITORS (GOVERNMENT DELEGATION)

The Director of Schools Cde Makopo informed the house about the visit to the A.N.C. establishments Mazimbu/Dakawa by the Government delegation from the Ministry of Higher Education Science and Technology and the Prime Minister's office on the 27 August 1991.

Issues to be discussed will cover phase-out period and security of the movement's property.

SAM'S INN
