EXPLAINING THE INDABA

MEMBERS OF the Chamber's Council of Directors and Standing Committees crowded in last week to hear Prof. Desmond Clarence, Chairman of the KwaZulu/Natal Indaba, outline the course of the Indaba discussions last year, and explain how those around the Indaba horseshoe had finally negotiated the compromise proposals which were eventually endorsed and presented to Government.

PROFESSOR CLARENCE explained how the proposals for a two Chamber legislature had been formulated after eight months of discussion and negotiation, in an effort to balance the demands of those who wished to abandon race discrimination with those who pressed for the protection of group rights and for the sharing of power. He emphasised that the proposals were not the first choice of any one of the 37 delegations taking part, but represented a true compromise.

PROF. CLARENCE said that while the Indaba was sitting it received a great deal of publicity because it had been convened at a time when social unrest was rife and when everybody was looking for conceptual solutions to the country's socio-political Recounting a number of humorous inciproblems. dents that had arisen during the course of the discussions, he said that as the Indaba proceeded delegates increasingly found that they could raise sensitive matters in discussion without any fear of giving offence, and that he had found this a All delegates, whether they great experience. signed the final proposals or not, had shown great sincerity in their wish to compromise as far as possible.

THE PROFESSOR'S address was followed by a lively question and answer session to clarify a number of queries on the working of the two Chamber system, and how minority groups would be represented on the Executive. In reply to one question Professor Clarence said he had no doubt that massive overseas funding would become available to develop the "new Natal", if the Indaba proposals were implemented. A number of United States companies

who had already left the Republic might also return.

IN VIEW of the keen interest shown in the Indaba address, and as a service to members who could not be included in the invitation to attend last week's meeting, the Chamber has decided to host a series of group presentations on the Indaba proposals and communications campaign. These will be specially for Chamber members and will take place in the Royal Hotel, Durban, on three consecutive days from 7 to 9 April and again from 21 to 23 On each day there will be present at ions and an opportunity for questions and discussion during lunch time from 12h45 to 14h00, and again from 17h15 to 18h30. There will be no entrance fee and snacks will be provided together with cash bar facilities.

MEMBERS WISHING to attend a presentation are asked to complete and return the reply form on page 13, indicating in order of preference the times and dates when they are free to attend. They will then be advised of the time and date of the presentation in which they have been included. As the numbers attending each presentation will be limited early booking is essential and replies must reach the Chamber not later than 30 March 1987.

THE INDABA has indicated that if there is sufficient interest within any one Chamber firm it will be happy to arrange a presentation for that firm to its management and staff on its own premises. In that event please indicate accordingly on the reply form.

The Association of Chambers of Commerce (ASSOCOM) and its constituent Chambers have contributed to the achievement of, or have been responsible for the following:

WHITE PAPER ON NATIONAL TRANSPORT POLICY

The long awaited White Paper on National Transport Policy has been tabled in Parliament.

Assocom was the initiator of the study and has been a driving force in the work of the Steering Committee whose recommendations have, with a few minor exceptions, been endorsed by Government.

Assocom is studying the document and the draft legislation, and Bills which have already been made available for comment.

A seminar on the subject is to be held in June and it is hoped that the Minister of Transport Affairs will officiate. Date, venue and time will be confirmed shortly.

LEGISLATION CONCERNING NTPS RECOMMENDATIONS

Assocom has commented on the following draft legis-

- * Road Traffic Bill
- * National Roads Bill
- * National Roads Board Bill, and on the
- * Tourism Laws Amendment Bill

Other draft legislation under consideration is:

- * Draft Transport Tribunal Bill
- * Draft Air Services Bill
- * Transport Advisory Council Bill

MEETING WITH S.A. BLACK TAXI ASSOCIATION

Association on March 17 to discuss the deregulation of Kombi Taxis as proposed in the White Paper on National Transport Policy.

REST AND SERVICE AREAS ALONG NATIONAL ROADS

The Department of Economic Affairs and Technology has confirmed that its only interest in rest and service areas concerns fuel reselling facilities which will be established in terms of the Service Station Rationalisation Plan. All other sites fall within the jurisdiction of the Department of Transport. Assocom has asked the Department of Transport for details of progress made with the estab-

lishment of other sites.

INCREASE IN DUTY FREE ALLOWANCES FOR TOURISTS

Following Durban Chamber representations, Assocom has requested the Department of Finance to increase the duty free allowances to travellers as follows:

- * The value of goods which can be brought back into the Republic as accompanied luggage without producing an import permit - R2 500, and
- * Duty free allowance on other goods R500.

DEREGULATION

In discussion with the Competition Board, it was understood that they have advanced considerably in examining and proposing alterations to the regulations which cover certain aspects relating to the licensing of businesses. Assocom hopes it will be given the opportunity to comment on these proposals. Nonetheless, it is evident that the whole de-regulation process is akin to peeling the skins of f an onion. That is to say, that the removal of certain regulations merely reveals further regulations underneath which could present continued obstacles to business.

Insofar as regulations pertaining to local authority issues are concerned, Chambers may well consider examining their local by-laws with a view to identifying those regulations which in their view present unnecessary obstacles to the performance of business. Assocom has acquired the services, on a temporary basis, of Mrs Janet Dickman to assist in this task.

THEFT/SHRINKAGE

Prof. C M Naude (Prof. of Criminology, UNISA) presented an interesting paper to the Distribution Committee at its recent meeting. The issue of employee theft is obviously a serious problem in South Africa, particularly for small concerns. The tragedy seems to be that society treats this form of theft lightly and in fact, distinguishes it from blatant theft by the euphemistic term "shop lifting" - a sad reflection on the state of morals of the country!!! The Committee will make recommendations on what further steps can be taken by Assocom.

TRADE PRACTICE ACT

It has become apparent to Assocom that new legislation is to be drafted which will extend the scope and powers of the Advisory Committee on Trade Practices. It should come as no surprise if this falls under legislation that will cover the whole gamut of consumer protection.

Chamber Topics

CREDIT CARDS

At a recent meeting of the Assocom Distribution Committee it was reported that there were indications that the Banks will be approaching Government to allow them to raise User Charges on Credit Cards which would mean that the Merchants Fee to business would be reduced. It was pointed out that for cash businesses credit cards were another expense which could impact on the price of goods and have an inflationary effect.

On the other hand, retailers did derive benefit from the credit card system (no bad cheques - a means of accepting payment by merchants who don't give credit). In order to avert a further increase in the cost of credit cards to retailers, the Committee agreed that a case be prepared in conjunction with the Association of Credit Card Users for an increase in user charges on credit cards to be taken up with the Authorities.

Before doing so, however, Assocom has invited the views of Chambers. If any member should be opposed to this proposal, it would be appreciated if written representations would be addressed to the Chamber by return of post.

DISCUSSIONS WITH THE CITY ENGINEER

City Engineer Don Macleod met with President Brian Hill and other Chamber representatives last week in the interests of closer communication on matters of common concern. The cordial and constructive exchange of views on items currently before the Chamber's Civic Affairs Standing Committee was most helpful and it is hoped that similar further discussions will be held from time to time with the City Engineer who has also offered to address the Committee on particular issues where this would assist its deliberations.

REGIONAL SERVICES COUNCILS - ANOTHER PROBLEM

It is well known that the voting power of participating local authorities on any proposed Regional Services Council is to be based on a formula related to the usage of R S C services in its area of jurisdiction. However, attention has recently been focused on the fact that the calculation of usage of these services excludes usage in demarcated business and industrial areas.

The effect of this provision in relation to any R S C for the Durban Metropolitan Area would therefore appear to be that usage of regional services in the whole of the Durban C B D and other commercial and

industrial areas would not qualify in determining the Durban City Council's representation on that RSC, nor would similar areas in other participating local authorities such as Pinetown. As the greater part of revenue to be raised for Regional Services Councils is by way of levies on the business community whose indirect representation is thus eliminated, this is a most serious issue and will be taken up in the strongest terms by the Chamber with the authorities.

REGIONAL EXPORT COMMITTEE MEETS

The Natal Regional Export Advisory Committee (NREAC), for which the Chamber acts as Secretaries, met last week to discuss a number of issues of concern to exporters including export incentives and forward exchange cover.

This has resulted in the formulation of representations to be submitted to the Private Sector Export Advisory Committee (PSEAC).

MEDICAL AID - SOME ACTION AT LAST

Concerned at the looming financial problems of Medical Aid Societies this Chamber as far back as 1985 moved a resolution at the Assocom Congress in Cape Iown that year calling for amendments to the Medical Schemes Act which would facilitate a more flexible approach. This resolution was presented to the Minister of Health in March 1986 when he indicated that he would only be prepared to amend the Act provided the two main parties, that is the medical profession and the medical schemes, could reach agreement on what was necessary. He suggested that employer bodies such as Chambers of Commerce should act as a catalyst in bringing the two parties together.

Following this the South African Employers Consultative Committee which is made up of representatives of Chambers of Commerce, Chambers of Industry, Sakekamers and so forth set up a work group on health care and this group has met on a number of occasions throughout 1986 and 1987 and has had discussions with both medical schemes and the medical profession.

Ihroughout 1986 the problems facing the medical schemes received a great deal of press publicity. Medical aid premiums escalated dramatically, many medical schemes reported financial difficulties and one or two had to close down.

A combination of all of these pressures has at long last forced the Minister to take action. Opening the Annual Congress of the Medical Association in Cape Town earlier this month National Health and Population Development Minister van Niekerk said that he had decided to convene a Conference in Pretoria on 9 April at which it was hoped to collect evidence of the problems being experienced and the sort of options interested parties would hope to offer to resolve these.

It is almost two years since this Chamber saw the writing on the wall and starting urging that something should be done. Hopefully at long last the necessary action will now be taken to amend the Medical Schemes Act and to give medical aid schemes the flexibility which they need to be able to offer affordable health care packages to commerce and industry.

THE EASTER HOLIDAY

GOOD FRIDAY, APRIL 17, 1987

A closed day for all general dealers in terms of Clause 34(1) of the Natal Licences and Business Hours Ordinance.

EASTER SATURDAY, APRIL 18, 1987

All shops may open in terms of the amendment to the Natal Licences and Business Hours Ordinance published in Natal Provincial Gazette No. 4526 of May 1, 1986, which deregulated shop hours in Natal.

EASTER SUNDAY, APRIL 19, 1987

Easter Sunday is now a closed day for all general dealers irrespective of whether traders previously were permitted to open for business on that day. Traders who ignore the law and choose to open will run the risk of being fined.

The concern of a number of beachfront traders about this development has been supported by the Chamber and representations have been made calling for the removal of Easter Sunday from the list of compulsory closed days. Even if successful, a change this Easter is unlikely.

Meanwhile, members who wish to open on Easter Sunday, may, in terms of Section 32 of the Ordinance apply to the Administrator of Natal for special opening and closing hours. Applications should be directed to the Provincial Secretary, Natal Provincial Administration, Private Bag 9037, Pietermaritzburg, 3200.

FAMILY DAY, APRIL 20, 1987

All shops may open in terms of the amendment to the Natal Licences and Business Hours Ordinance published in Natal Provincial Gazette No. 4526 of May 1, 1986, which deregulated shop hours in Natal.

Liquor Stores

Liquor stores which are governed by the Liquor Act will conduct business as follows over the Easter

week-end:

Good Friday :

Closed.

Easter Saturday:

Normal Saturday hours.

Easter Sunday :

Closed.

Family Day :

Closed.

Major Banks and Building Societies

Most major building societies and banks will close on Good Friday, Easter Sunday and Family Day, but will open as usual on Easter Saturday.

Industry

As far as the industrial sector is concerned each industry is governed by its own Industrial Council Agreement or other labour legislation. Members should clarify the position regarding their own industry with the appropriate Industrial Council, or the Department of Manpower. Industries not falling within any particular labour legislation should note that in terms of the Basic Conditions of Employment Act Good Friday is a public holiday but not Family Day.

EFFECTS ON ORDINARY LEGAL PROVISIONS GOVERNING MAXI-MUM ORDINARY HOURS OF WORK

These extended hours do not affect br override the ordinary legal requirements governing maximum ordinary hours of work and payment for overtime which may apply to the business in question. These may be found either in the Basic Conditions of Employment Act 1983 or the appropriate Wage Determination or Industrial Council Agreement for the trade in question.

If the business falls within the scope of Wage Determination 406 for the Commercial Distributive Trade, then a 10% "night work allowance" will also be payable to certain staff required to work between the hours of 19h00 and 06h00. The relevant section of Determination 406 reads:-

"Night work allowance - an employer who requires or permits his employee to perform night work shall pay such employee in addition to his wage, an allowance at a rate of not less than 10% of his hourly wage for each hour or part of an hour worked by such employee on night work, provided that this sub-clause shall not apply to a manager, security guard, watchman or an employee who is excluded from the hours of work provisions by virtue of clause 5 (9)(a)."

SALES TAX/VAT LIQUOR INDUSTRY

It has happened! Readers will be aware that under legislation published in the Government Gazette in February last, new sales tax procedures were introduced for the liquor industry, representating nothing short of a VAI system.

Assocom is concerned that this development might well be a forerunner for its extension. Assocom continues to stand by its opposition to VAI and will continue to promote its view with the Authorities.

MONEY SUPPLY TARGETS FOR 1987

Assocom was represented at a media conference convened by the S A Reserve Bank in Pretoria on March 10, 1987, at which the Governor Dr Gerhard de Kock, spelt out the money supply targets for 1987. He stated that the South African economy was moving slowly off a low base; that there was little danger of the economy over-heating, which could lead to the re-emergence of demand-led inflation; the monetary authorities would do their best to ensure interest rates remained low: it is not the intention to increase or decrease the Bank rate - however, should the money supply growth be inadequate by June, there may be some additional fiscal stimulation in the Budget: Bank credit was not expected to rise significantly in the next few months, nor would inflation decline sharply, although there could be gradual downward tendencies. A wage and salary freeze would not be recommended as this would further devastate real remuneration which had declined for two years. Dr de Kock stressed the fact that South Africa had no soft option. For political reasons a current deficit could not be financed with foreign capital. Any further adjustment to the prevailing circumstances will have to be done the hard way. So far the cost had been a decline in employment and the standard of living. He also stated that should South Africa experience a strong upswing resulting in a rise in imports, the Authorities would not dip into reserve but would use trade credits.

ASSOCOM IN CAPE TOWN

The Assocom Board of Management, the Chief Executive, and several senior members of the staff were active in Cape Town from 23 - 25 February 1987, for a meeting of the Board, as well as a series of interviews with the State President, Cabinet Ministers, Deputy Ministers, Members of the President's Council and Chairmen of Parliamentary Standing Committees, and several Parliamentarians to discuss

certain Congress Motions, including political reform, economic and other vital issues of the day.

Although it was not possible to hold the annual Parliamentary briefing because of the early closure of the Parliamentary Session pending the General Election on May 6, 1987, a well-attended Parliamentary cocktail reception was held.

REGISTRATION OF SERVICES - TYPE UNIFORMS DRAFT

This Bill envisages the control of the wearing of uniforms so as not to cause confusion in the mind of the public and to reduce threats to security. In Assocom's detailed submission on the provisions of the Bill to the Director-General, National Education, several questions, observations and reservations were put forward. The thrust of the representations are that notwithstanding the laudible objectives of the proposed legislation, Assocom questioned the need for the legislation, particularly in the light of the current emphasis on the need to de-regulate, and the stated Government policy of minimum interference in the economy.

FOCUS ON UMHLANGA

At the recent SECOND meeting of the Chamber's Umhlanga Committee, mention was made of the success of the Umhlanga Festival and the Committee's efforts to ensure that success - which included the participation of a Chamber float - was reviewed.

The considerable preliminary work done by the Tourism Publicity Sub-Committee which is investigating ways and means of giving adequate countrywide publicity to Umhlanga Rocks which has so far been lacking, also received attention.

A report was given on the preliminary efforts of the Security Sub-Committee which is investigating ways and means of creating greater awareness in Umhlanga Rocks of the need to improve security and to encourage everyone to do their utmost to that end.

The Borough Council requires comment on proposals for the new road system for Umhlanga Rocks by 31 March. This matter is to receive further consideration before the Committee's final views are submitted and local members having any comments on these proposals are invited to inform the Chamber as soon as possible.



HOW JUNE | 1987 AFFECTS FACTORIES

As members may be aware June 1, 1987 has been declared a special Public Holiday by the State President to celebrate the 26th Anniversary of the Republic of South Africa, because May 31, 1987 falls on a Sunday.

Although June 1, will be a paid public holiday for shops and offices in terms of the Basic Conditions of Employment Act, it will not be a paid holiday for factories. The definition of public holidays for "factories" in the Act specifies the days which are regarded as public holidays for industry. The Basic Conditions of Employment Act does not provide for days which are declared as public holidays by proclamation to be paid public holidays for factories. As June 1, 1987 is an additional public holiday and is not a substitute for Republic Day it will not be regarded as a paid public holiday for factories unless specific provision is made for this in a wage regulating measure for a particular industry, trade or occupation.

Members falling within the scope of Wage Determinations or Wage Agreements should consult these to ascertain what the status of June 1, 1987 is for their particular industry.

LOCAL POSTAL TARIFFS UP FROM I APRIL

As from April 1, the postage rate for standardised mail for destinations within South Africa and South West Africa will increase from 14 cents to 16 cents.

The definition of a standardised mail item is an item in a sealed envelope with a maximum mass of 50 grams, maximum size of 120 mm x 235 mm, a minimum size of 90 mm x 140 mm of a maximum thickness of 5 mm.

The above increase affects only standardised mail and all other postage rates remain unchanged.

10% DISCOUNT TOLL ROAD DEBIT CARDS AVAILABLE

Commercial vehicle owners who make frequent use of the Mariannhill Toll Road, are reminded that as a service to members the Chamber has stocks of R6O Toll Debit Cards Type H, which are available at the attractive price of R54 per card.

Commercial vehicles with two truck axles can utilise the card up to 50 times dependent upon the number of wheels in contact with the road. A vehicle with 5 or more axles, for example, will pass through the toll gate 20 times.

The Type H debit card is valid for any vehicle class, however extensive use for light vehicles may cause malfunctioning of the card. (A two axled light vehicle can pass through the toll gate 150 times).

Apart from being freely transferable for use for any category of vehicle, the card obviates the need to obtain and carry small change.

Cards are obtainable, on a cash-with-order basis, from the Accounts Department of the Chamber, 2nd Floor Commerce House, 39 Field Street, Durban.

FOREIGN TRADE TOPICS

WINE AND TOBACCO MARKET : TAIWAN

The Taiwanese Government has opened its US\$1-B a year market for wine and tobacco products to South African producers, by replacing import controls on wine and tobacco with import duties.

CHICAGO BOARD OF TRADE

The Chicago Board of Trade (CBOT) is the world's oldest and largest commodity futures exchange, with 1402 full members, 600 associate members, as well as some 700 others with limited trading privileges.

The CBOI provides a central facility where members can trade futures and options on futures contracts. The exchange does not buy or sell commodities, nor set prices. Futures and options-on-futures, are traded on the floor of the exchange by open outcry in a free competitive market.

Futures contracts are commitments to deliver or receive delivery of a specified quantity and grade of a commodity, during a designated month at a price that is determined by public auction. Among buyers and sellers of futures contracts are producers and commercial users of commodities and various types of money managers.

TRADING WITH JAPAN

Japan, which is South Africa's second largest trading partner, is now the second largest market in the world for consumer and industrial goods. The 1987 issue of Journal of Japanese Trade, which is issued bi-monthly in six volumes, gives the answers to questions on how Japan has achieved its success in world trade. The Board of Trade and Industries has stated that FOB will be retained as the basis for customs valuation.

As an outflow from the Kleu Committee into Industrial Strategy the Board of Trade and Industries has launched a further investigation into industrial development in South Africa.

CORRESPONDENCE WITH SOUTH AMERICAN COMPANIES

The South African Vice-Consul (Trade) in Buenos Aires, Argentina, has drawn to the attention of South African exporters that correspondence to the South American continent should be forwarded by airmail. He writes that surface mail takes up to four months to reach Argentina, Uruguay, Paraguay and Bolivia with the subsequent loss of export opportunities.

The Department of Trade and Industry will consider granting financial assistance to companies wishing to participate individually in these specialised fairs. A high percentage of the following expenses are usually taken into account:

Rental of exhibition space, construction of stand (excluding interior decoration), telephone installation, electrical installation and consumption and the rental of essential furniture.

Transport costs, forwarding charges and clearing charges, subsistance and entertainment expenses are not eligible.

Exhibitors are required to submit applications prior to participating in an exhibition. On receipt of applications the Department will indicate to what extent it is able to contribute to the actual cost. After termination of the show a claim (Continued on Page 11)

STATISTICAL NEWS

CONSUMER PRICE INDEX JANUARY 1987

Following the publication in last week's Digest of the January 1987 Consumer Price Index, the following additional information has been received from Assocom's Statistician.

Members may be aware that the Consumer Price Index indices relating to different urban areas do not permit inter-urban comparisons of price levels or living costs and do not indicate whether it is more expensive to live in one city than in another. For each urban area, independently of any of the other urban areas, the Consumer Price Index indicates the price changes which have taken place from time to Inter-urban comparisons may, however, be made on the grounds of the information contained in the following table. This table compares eleven of

the twelve urban areas, with the Witwatersrand made

Economic imbalances between regions are evident from the above table: the three most important regions, namely H, E and A, accounted for 41,4%, 14,0% and 13,0%, respectively, of total GGP. Combined, these three regions contributed more than two-thirds (68,4%) to GGP. In contrast, the three regions contributing least to GGP, namely regions B G and J, collectively accounted for only 10,2% of total GGP. From the table, it can be seen that the population is also unevenly divided between the 9 regions, but regions with relatively large shares of total population did not necessarily have large shares of the total GGP. For instance, region G, with 11,3% of total population, contributed only 2,6% to total output and had by far the lowest GGP per capita, namely R763, or only 12,4% of the per capita output of region H (PWV region), which region had the highest GGP per capita (R6 177). Region F (Eastern Iv1) had the second highest per capita production (R4847), with region A (Western Cape) taking third place with R4 685 and region J (Western Iv1) in the fourth place (R3 639). 


