ORGANISATIONAL RESOLUTION

The 7th Congress of AAPSO, held in New Delhi from the 24th to 28th November, 1988,

Having extensively deliberated on the organisational aspects of the AAPSO's activity,

Taking into account the decisive changes that took place on the international arena and the objective need to improve the organisation's stature, so as to better accomplish its strategy and future tasks, and

Having thoroughly discussed the results reached by the Ad-Hoc Committee in its two meetings in July and October respectively in Nicosia and Cairo and the drafts it presented to the Congress:

1. Ratifies the amended constitution of AAPSO.
2. Unanimously elects Dr. Morad Ghaleb President of AAPSO and Mr. Nouri Abdul Razzak Secretary-General of AAPSO, done by acclamation .
3. Elects the Vice Presidents of AAPSO as in Annex No.1 of this resolution.
4. Designates the Presidium Committees of AAPSO as in the same Annex of this resolution and enjoins the Permanent Secretariat to call for regular meetings of these organs of the AAPSO.
5. Elects the members of the Permanent Secretariat as in Annex No.2 of this resolution. It is expected that the respective National Committees will provide financially for their representative in the Permanent Secretariat.
6. The Congress resolves that:
 - (a) the Moroccan Committee of Peace, Solidarity and Friendship between Peoples is granted membership of AAPSO;
 - (b) the British Afro-Asian Solidarity Organisation is granted associate membership of AAPSO;
 - (c) the National Committee in Nicaragua is granted associate membership of AAPSO.

(d) To ask the Permanent Secretariat to gather further data on the application for membership of

- (1) BANU (Burundi African National Union) based in Dar Es-Salaam.
- (2) Ivory Coast Committee of Solidarity and Peace of Afro-Asian Peoples.

7. Takes note that the Yemeni Peace and Solidarity Movement endeavours to achieve its unity in both parts of Yemen, that according to the understanding reached, at the beginning of November 1988 in Aden, between the three parties, all agreed that the Peace and Solidarity Council in San'aa joins the International Peace and Solidarity Movement, provided that the National Council of Peace and Solidarity retains its membership as it is, and that unification be achieved within one year of date, and that the Yemeni Peace and Solidarity Movement be unified in both parts of the Yemeni homeland in a lapse of time of no longer than one year of date, and that its headquarters be in San'aa, the Capital of the Yemeni Unity.

8. Resolves that the National Committee of the country of headquarters be invited to the meetings of the Bureau of the Presidium of AAPSO.

9. Resolves that the National associate members of G.D.R., Czechoslovakia, France, Finland and Nicaragua be members of the Presidium Bureau of AAPSO, and be represented respectively by Mr. Reichart, Mr. Vacik, Mr. C.Gatignon, Mrs.C.Sevon and a permanent representative of Nicaragua.

10. The Congress takes note of the Permanent Secretariat's report as regards the "Recommendations by the Fourth Meeting of the Presidium Bureau", the "Resolution on Organisational Matters of the 14th Session of the AAPSO Presidium" and enjoins the Permanent Secretariat to continue its efforts for further improvements of its functions.

11. Calls upon all National Committees to pay their annual subscriptions to the regular budget of the Permanent Secretariat as stipulated by the Constitution.

12. Mandates the Bureau of the Presidium of AAPSO to convene not later than March 1989 and to finalise, in ^{that} meeting, the Programme of Action for the years 1989-1990 based on the initiatives of National Committees.
