MISSION STATEMENT

The Johannesburg Civic Theatre must be transformed in accordance with democratic principles to the benefit of all the people of the greater Johannesburg. Metropolitan area.

- 1. The process of transformation cannot take place without the full participation of the relevant cultural structures that are in tune with the needs and aspirations of all communities.
- 2. The process of transformation must also be placed in the national negotiations context.
- 3. In order for this process to begin, it is necessary to reconstitute the board of the Civic Theatre Association and implement any changes required to the Articles of Association of the Civic Theatre Association to effect this transformation.
- 4. This will require a joint commission. The terms of reference of the commission and decisions reached shall be legally binding.
- 5. The principle of Public Accountability with regard to expenditure and planning must be accepted immediately.
- 6. All major artistic and managerial appointments must be done in the joint commission.
- 7. Issues of funding, venues, accessibility and resources must be discussed as a matter of urgency, by the joint commission.
- 9. All culture initiatives to import foreign companies or artists will be dealt with by the commission.
- 10. The DAC will facilitate formation of the commission. The commission will consists of ACAC, PAWE, SAMA and Civic Theatre board members
