The chair gave the floor to Gavin as he is the person who has requested the meeting.

Gavin explained that he saw it necessary that such a meeting should be called because he is seeing some problems in the way the cars are being handled. That since people have informally identified cars which they are to buy, some individuals are beginning to be protective of our 'private cars' at the expense of the office work.

That as far as he can remember it was agreed that even if individuals do buy the cars but they will continue to serve the office until such time that the office closes.

He then revealed that when he went to comrade Sipho wanting to use the van Sipho refused and he (Themba) also pointed i out that there are some people in the office who are also suffering from the same diseases of protecting their cars.

That he had then concluded that this problem must be discussed before it reaches an ugly stage.

That when he wanted the vehicle from Themba he was not doing his own personal things but wanted to fetch Chileshe.

He had then also thought that this problem does not affect Themba alone but the whole collective should solve it.

At this point minutes were read out to the meeting which explained that as long as the office exists the cars to be bought by the staff will continue to serve the office until such time that the office closes.

It was then resolved that this issue should apply to everybody and that people should always try to make sure

After some questions were raised as to which car is the Chief Rep interested in it was explained that chief had never shown interest in buying any car.

Although it was also mentioned that Chief had said that he had overheard somebody saying that the landcruiser is going home the meeting decided that the white cressida should also not be sold but should remain in case the chief rep wants to buy a car.

It was also decided that in future all decisions of the administration should be respected and that the white combi which was driven by Themba should be earmarked for Kenneth Maduna and that Comrade Alfred will convince Kenneth and an excuse should be that some cars have been taken home for the elections campaign.

Also agreed was (as chief had proposed) that the NIVA should be sold and not take it back to the Russians since the agreement between the Former Soviet Union and Sactu is not known.

That the funds from sale of NIVA should be deposited to the office and not be given to Comrade George Naicker because he won't be easy when the office wants money from him.

It was then finally agreed that Comrades Awolo Mogau and Gavin Lobelo should be the one to brief Comrade George Naicker on the decisions taken by the administration.

Additional points raised.

a) That it is unfair for the TGO Committee to use local evaluators to value cars that are to be bought by the staff whilst when the first batch of cars was sold it was Kaya who was doing the evaluation. That the local evaluators are charging local market prices which the staff cannot afford

It was also pointed out that in the case of Comrade Awolo and Jacob they bought their cars at a very considerate prices so that must apply also to the other staff members.

It was then said that Comrade Moosajee and George will have to do the evaluations themselves. ,

Comrade Xolani also complained that he feels left out and not part of the collective. That whenever work has to be done he is collected but whenever he has to attend to his personal problems he is not provided with transport.

He quoted examples where even when going to the doctor he has to use public transport, same as when attending his own school problems.

He went further to state that this he feels is insensitivity of the office members towards him and that he does his shopping using the public transport because people seem to remember him only when there is work.

It was then resolved that staff members should try to assist one another so that there is not one who will feel left out of the collective.

On Chileshe's issue it was agreed that a place a Aaron's residence will have to be found for him and that Aaron will have to be told.

That Chileshe must be made to understand that he has to look for his own accommodation.

On the question of the people running away from the camps it was pointed out that it is no use to dismiss them but a person(s) should be appointed so as to attend these people when they arrive and interview them.

Comrades Themba and Aaron were chosen for the job but it was pointed out very clearly that this arrangement was only a temporary arrangement and that if Tony and Dexter comes back they are the people who will handle the issue as it is their job.

It was then also agreed that Comrade Dexter should be requested to prepare a questionnaire so that the people should be interviewed before they are sent to Johannesburg.

Also resolved was the administration should be holding meetings every friday at 08:30 so that it does not find itself having to meet when there are problems. a

At this point Comrade Dexter Mbona was called and he explained that he is coming back to Zambia and therefore he is requesting that he be considered for transport, petrol and accommodation at the former JM's house.

He revealed that he was suppose to come with a letter from HQ explaining his position.

He was then strongly called to attention over his behaviour of handing his car to Tony and not to the administration when he left for South Africa.

It was explained that the administration does not expect that to happen again as he is also aware of the decisions of the administration on the sh'te.

It was then resolved that t car will be packed at Comrade Awolo's place.
