EXTRACT FROM SPEECH MADE BY JANNIE MOMBERG, AND MEMBER OF PARLIAMENT FOR SIMON'S TOWN AT THE AGM OF THE WYNBERG AND BRANCH ON SUNDAY 16TH AUGUST 1992

THE ATTITUDE OF THOUSANDS OF WHITES AT ELLIS PARK AT THE TEST YESTER-DAY WAS A SHOCKING EXAMPLE OF WHITE INSENSITIVITY TOWARDS BLACKS.

THE SINGING OF DIE STEM WHEN A MOMENT OF SILENCE FOR PEACE WAS ASKED, WAS THE HEIGHT OF WHITE ARROGANCE.

THE BLUNT REJECTION BY DR LUYT OF THE AGREEMENT BETWEEN THE ANC AND SARFU HAS NOW CAST A SHAWDOW OVER THE TEST AT NEWLANDS AND FUTURE RUGBY TEST MATCHES.

I CALL ON THE SARFU TO CENSURE DR LUYT AND THE TRANSVAAL RUGBY UNION IN THE STRONGEST POSSIBLE WAY.

THEY MUST SHOW THE BLACK PEOPLE OF THIS COUNTRY THAT THEY HAVE FEELINGS THAT THEY UNDERSTAND THEIR HURT AND PAIN AND THAT THEY HAVE COME TO A DECISION TO DISCIPLINE DR LUYT ONCE AND FOR ALL. IT IS NECESSARY TO REMOVE THE CURRIE CUP FINAL FROM ELLIS PARK ON THE 12TH SEPTEMBER, AS WELL AS PLACE A MORATORIUM OF TEST MATCHES AT ELLIS PARK, INCLUDING THE WORLD CUP.

I ALSO CALL ON THE WESTERN PROVINCE RUGBY UNION TO SHOW ITS UNDER-STANDING OF THE POLITICAL ISSUES AROUND NEXT SATURDAY'S TEST AGAINST THE WALLABIES AND TO STRICTLY ADHERE TO THE AGREEMENT BETWEEN THE ANC AND THE SARFU.

SUBJECT MATTER: ANC INITIATIVE ON DROUGHT RELIEF

DECISIONS REQUIRED

That the ANC convene a Drought Summit of national leaders from the Political, Business and NGO Community.

That ANC leaders, especially the officials, visit some of 2. the areas worst affected by drought. Such visits to have the press corps in attendance.

BACKGROUND

The drought is now reaching crisis proportions in South Africa. The crisis will exacerbate until the harvest for the current growing season around May 1993.

Drought relief is so structured that people in the bantustans and farm workers currently have little access to relief. a growing perception that the ANC is uncaring about this very real plight of the people. Significant mileage can be made from initiative in respect of this issue. The profile of the President should be utilised to generate maximum support. will be a Consultative Forum on Drought on 26 August - this occasion may be the opportunity for the ANC to take the appropriate initiative.

SUBJECT MATTER: ATTEMPTS BY SOUTH AFRICA TO JOIN A NEW CONSTITUENCY AT THE IMF AND THE WORLD BANK.

DECISIONS REQUIRED:

- 1. That permission be granted for a delegation to meet with the Minister of Finance, Derek Keys, to discuss the matter before 21 August. The purpose of the meeting would be to state a position which would seek to dissuade the regime from proceeding with moves to join the new constituency.
- 2. If reason fails to pursuade them, we should be permitted to campaign vigorously at all levels to embarass the regime and this particular initiative. It falls within the ambit of unilateral restructuring, about which we have a resolution of the Policy Conference.

BACKGROUND INFORMATION:

Since 1974 South africa has technically been in the wilderness at the IMF and the World Bank. In respect of the IMF it currently finds itself in the European constituency. Switzerland is now joining the IMF/WB and wants to establish a new constituency. To date the Swiss have approached SA, Poland, Turkey and certain CIS states to join their constituency. Certain proposals have been put by the Swiss including the fact that they will retain a stake in the Directorship, taking the first Executive Director's position 1992/4, with SA having the alternate and a swop will be effected in 1994.

In Africa there are two constituencies at present viz Anglophone and Francophone. Both have approached the ANC with the view to future membership. There is a strong likelihood that the Francophone constituency, the smallest in the IMF, would be shut down because the directorship of the IMF is opposed to the establishment of a new seat on the board. Africa would then be represented by only one seat on the board.

Both Switzerland and South Africa want the issue to be resolved before the Annual IMF/WB meetings to be held in Washington DC on 22 September. In fact, a SA delegation will be travelling to Switzerland for a meeting on Friday 21 August.

Key sources in the World Bank and the IMF are of the view that South Africa's membership could stand over until 1994 when next there will be elections in the institutions.

THE DEBATE:

The government argues that accession to the Swiss constituency has particular advantages including the fact that SA will have a seat on the Board in 1994, whereas in Africa we will have to wait much longer because directorship rotates on a 2 year cycle for each country. They also argue that friendliness to Switzerland will increase access to lending capital.

The other side of the debate is that the political circumstances do not allow for such a bold move at this juncture. We should also not be seen to be party to an initiative which will contribute the marginalisation of Africa. There is nothing preventing SA from joining the Swiss constituency in 1994, or beyond, should a democratic government so decide.

SECURITY COUNCIL RESOLUTION

DRAFT STATEMENT ON SECURITY COUNCIL RESOLUTION.
The ANC welcomes the Security Council resolution-772-----

----, adopted on the 17th August 1992.

We re-affirm our appreciation of the urgency with which this matter has been handled. The violence in South Africa has led to many deaths and incalculable damage to very fabric of our society. This issue has now been put firmly on the agenda of the international community and we are confident that the efforts of those within and outside the National Peace Accord structures, who are genuinely attempting to stop the violence, will meet with greater success.

The resolution accepts the legitimacy of our struggle for a non-racial democratic and united SA and re-affirms the United Nations commitment to remain seized with the issue until this objective is achieved.

We welcome the fact that the resolution identifies the areas of concern to be hostels, dangerous weapons, the role of the security forces and other armed formations, the investigation and prosecution of criminal conduct, mass demonstrations and the conduct of political parities. This is in accordance with the findings of the Goldstone Commission and other investigations and is in accordance with our consistently expressed view that if these matters are effectively addressed we can successfully tackle the violence.

We note with satisfaction that the Secretary General has been given the authorization to urgently deploy sufficient observers to enable them to effectively address the areas of concern noted in his report. It is also significant that the resolution invites other international organisations such as the OAU, the Commonwealth and the European Community to deploy their own observers to SA.

The ANC also welcomes the fact that the UN observers will act independently but in close cooperation with the structures of the National Peace Accord.

The ANC commits itself to give the observer mission #its fullest cooperation.

ORIGINAL: ENGLISH

The Security Council,

Reaffirming its resolution 765 (1992) of 16 July 1992,

Having considered the report of the Secretary-General on the question of South Africa (S/24389),

Determined to help the people of South Africa in their legitimate struggle for a non-racial, democratic society,

Cognizant of the expectations of the people of South Africa that the United
Nations will assist with regard to the removal of all obstacles to the resumption of the process of negotiations,

Bearing in mind the areas of concern relevant to the question of violence in South Africa, including the issues of the hostels, dangerous weapons, the role of the security forces and other armed formations, the investigation and prosecution of criminal conduct, mass demonstrations and the conduct of political parties,

<u>Purther bearing in mind</u> the need to strengthen and reinforce the indigenous mechanisms set up under the National Peace Accord, so as to enhance their capacity in the building of peace, both in the present and in the future,

<u>Determined</u> to assist the people of South Africa to end violence, the continuation of which would seriously jeopardize peace and security in the region,

Underlining in this regard, the importance of all parties cooperating in the resumption of the megotiating process as speedily as possible,

- Welcomes with appreciation the report of the Secretary-General of 7 August 1992 (S/24389);
- Expresses its appreciation to all relevant parties in South Africa for the cooperation they extended to the Special Representative of the Secretary-General;
- 3. <u>Calls upon</u> the South African Government and all parties in South Africa to implement urgently the relevant recommendations of the Secretary-General contained in his report;

- 4. Authorizes the Secretary-General to deploy, as a matter of urgency, United Nations observers in South Africa, in such a manner and in such numbers as he determines necessary to address effectively the areas of concern noted in his report, in coordination with the structures set up under the National Peace Accord;
- 5. <u>Invites</u> the Secretary-General to assist in the strengthening of the structures set up under the National Peace Accord in consultation with the relevant parties;
- 6. Requests the Secretary-General to report to the Security Council quarterly, or more frequently if necessary, on the implementation of the present resolution;
- 7. Calls on the Government of South Africa, parties and organizations, and the Peace Accord structures, to extend their full cooperation to the United Nations observers to enable them to carry out their tasks effectively;
- 8. <u>Invites</u> international organizations such as the Organization of African Unity, the Commonwealth and the European Community to consider deploying their own observers in South Africa in coordination with the United Nations and the structures set up under the National Peace Accord;

9. Decides to remain seized of the matter until a democratic, non-racial and united South Africa is established.
