A moment of prayer/meditation was observed by all members.

Welcome and Attendance

- 2.1 The participants were welcomed.
- 2.2 Apologies were noted on behalf of L Landers and Chief Nonkonya}la for a late arrival.

Ratification of the Agenda

The agenda was ratified with no amendments.

Meetings Schedule

- $4.1~\mbox{A}$ proposed meetings schedule as recommended by the Planning Committee was agreed to (see Addendum B).
- 4.2 It was noted that, although a Negotiating Forum is scheduled for 25 June 1993, if sufficient progress was made and it was deemed necessary by the Negotiating Council, the date could be brought forward.

Minutes

- 5.1 The minutes of the meeting of the Negotiating Council of 27 May 1993 were ratified with the following amendments:

Substantive Issues

Reports of the Technical Committees:
6.1.1 Technical Committee on Constitutional Issues:

- 6.1.1.1 The members of the Technical Committee were welcomed. Present were F Cachalia, A Chaskalson, GE Devenish, B Ngoepe, M Olivier, W Olivier, F Venter and M Wiechers. Apologies from E Moseneke were noted.
- 6.1.1.2 It was noted that the Technical Committee is present in the Negotiating Council for questions of clarification only and debate should take place amongst participants.
- 6.1.1.3 The Third Report of the Technical Committee was formally tabled. The Technical Committee then presented an overview, highlights and issues which require decision/guidance from the Negotiating Council from the Second and Third Reports.

- 6.1.1.4 The KP at this stage requested an opportunity to present oral evidence to the Technical Committee. It was agreed that the KP present their submission in writing to the Technical Committee but this would not rule out the possibility of an oral presentation to the Technical Committee.
- 6.1.1.5 It was further agreed that should the Technical Committee be of the opinion that such an oral presentation would assist the process, it should advise the Negotiating Council thereof and that the Negotiating Council revisit this matter at its next meeting.
- 6.1.1.6 The KP noted that it reserved its right to address the Negotiating Council in line with the above request. A concern was raised by the KP that some delegations may have approached the Technical Committees on an informal basis; it was agreed that this issue be referred to the Planning Committee for a possible recommendation encompassing guidelines in this regard.
- 6.1.1.7 The following recommendation of the Planning Committee aimed to facilitate a more structured and pointed debate of the reports was then put to the meeting:

The Planning Committee recommends that the Negotiating Council look at:

" Constitutional Principles;
Principles on Regional Government;
= Process for the Democratic Creation and

Adoption of a Final Constitution;

in a holistic way with a view to facilitate complete and pointed discussion on these issues and in this way provide for decisions to be taken by the Negotiating Council which would enable the Technical Committee to proceed with its work.

These three issues are inter-related and will provide a framework to deal separately and collectively with the issues, as well as ensuring that concerns with regard to regional principles and constitutional issues are addressed.

This process will facilitate discussion within the Technical Committee and the Negotiating Council on the powers, functions and structures of States/Provinces/Regions. It will also lead to a provisional agreement which will enable the process to move forward. Within this process compromises may also be found.

Therefore these issues should be discussed in the following order:

The Transitional Process
Principles of Regional Government
* General Constitutional Principles

Discussion and the expressing of various views then followed. After discussion it was agreed to discuss the transitional process. The KP noted its disagreement in this regard.

Further discussion followed and a proposal was put forward to the meeting by the ANC and added to by the SA Government. It was then agreed that the meeting adjourn for the Planning Committee to meet to draft a proposed resolution on Constitutional Issues.

The meeting adjourned at 17h00 for tea and for the Planning Committee to draft the proposed resolution.

The meeting reconvened at 18h50.

SA Government/PAC Report Back:

6.3.1 It was noted that a bi-lateral meeting between the SA Government and the PAC had been held on Tuesday 1 June 1993 and a further bi-lateral meeting was scheduled for Thursday 3 June 1993. Furthermore, that both the SA Government and the PAC had issued statements with regard to the outcome of the bi-lateral.

The PAC expressed its concern that agreement could not be reached on various issues, such as the return of all documentation by the SAP and the immediate and unconditional release of PAC members. The PAC further noted that if the documentation was not returned by Thursday 3 June 1993 and the relevant PAC members are not released, the PAC would find it increasingly difficult to keep participating in the negotiating process.

The SA Government highlighted the following point with regard to the statement they released:

It is the view of the SA Government that no party that is still committed to and engaged in armed activities including the killing of people can participate in an election and any preparations leading to such an election. The PAC has so far failed to meet this condition. The SA Government is prepared to immediately enter into bi-lateral discussions with the PAC with a view to achieve the suspension of the armed struggle or a moratorium on all armed activities of the PAC and Apla. The SA Government is awaiting a response to this from the PAC on Thursday morning.

It was suggested that the Planning Committee consider the issue of the wording of certain placards by PAC supporters at the main gate, these not being in line with the spirit of the Multi-Party Negotiating Process.

IT IS RESOLVED THAT:

The Negotiating Council proceeds to negotiate and endeavour to agree on the constitutional principles recommended by the Technical Committee as set out in paragraph 2 of its Third Report, and the detailed principle dealing with the allocation of powers to different levels of government as set out in paragraph 3 of its Third Report.

There is a need for the adoption of a Constitution for the transitional period, the text of which is agreed to at the Multi-Party Negotiating Process:
