ALL AIRLINES AND TRAVEL AGENTS

Dear Sirs

Consequent to the suspension of Holiday Travel Allowance advaced in our Authorised Dealers Circular No. 18/82 of the 8th occour, 1982, it has been decided to regulate the sale of airline tickets and miscellaneous charges orders (MCOs) for international travel. This has necessitated the introduction of a Form AT (Air Travel) in respect of all persons travelling abroad from Zambia.

The effect of the introduction of the Form AT would be:-

- (i) All airlines will have to account for funds accumulating locally with them in a simple and straight forward manner than has been the case so far;
- (ii) That every person going abroad without Foreign Exchange would have to satisfy the Bank of Zambia that he/she has not made arrangement abroad to obtain Foreign Exchange in unauthorised manner. Therefore, no air booking should be made in the future unless either a person has obtained the Form AT approved by the Bank of Zambia, or has been issued Foreign Exchange by an authorised dealer in Foreign Exchange for his/her travel abroad under a specific permit issued by the Bank of Zambia for approved visit. The objective here is to ensure that persons have either obtained Foreign Exchange from the Bank of Zambia, or have their expenses genuinely mot by their close relatives or friends living abroad.

We reiterate that Form AT will have to be completed by all passengers travelling abroad, irrespective of whether the Foreign Exchange permit has been issued to them by the Bank of Zambia or not. In either case, airlines are requested to submit the Form AT in triplicate to the Lamb of Zambia Exchange Control Authorities for prior approval.

After approval, the form will be disposed of in the following manner:-

## (i) Original

This is the Bank of Zambia copy to be retained in the Bank.

# (ii) Duplicate

This is the airline copy. When an airline issues a ticket, the bottom right tear-off portion on page two, carrying the Bank of Zambia Exchange Control reference number, must be detached and securely pinned to the ticket. This is the testimony to any interested authority, e.g. Customs etc, to the effect that the ticket has been regularly obtained.

## (iii) Triplicate

This is the Authorised Dealer's copy to accompany an airline's deposits. The total of deposits backed by the Form AT so collected must always tally with the total of Bank of Zambia Exchange Control approvals borne on the corresponding original Forms AT.

Please find enclosed herein, an approved format of the Form AT to be in use.

RETURN OF AIR TICKETS SOLD/PASSAGE BOOKED

Further to A.D. Circular number 10/81 dated 21st July, 1981, all Airlines and Travel Agents in Zambia are hereby informed that with immediate effect in all cases of cancellations or refunc of passages booked, the Airline and/or the Travel Agent concerned shall advise the Bank of Zambia Exchange Control in writing within a week of cancellation or refund giving the following details:-

- (i) Names and address of passengers
- (ii) Reasons for cancellations/refund
- (iii) Date refund issued/effected
- (iv) Amount refunded
- (v) Whether travel allowance was surrendered to a commercial bank before cancellation of ticket
- (vi) Where re-issues are requested the return shall state so and give particulars of the original ticket(s) held advising manner of payment for any shortfall in the changed travel arrangements.

All other directives contained in the referred to circular remain the same.

#### PURCHASE OF AIR TICKETS BY NON-RESIDENTS

All Airlines and Travel Agents in Zambia are hereby informed that prior to issuance of ticket(s) in favour of non-residents of Zambia for international travel, the issuing office must ascertain that such ticket(s) are being issued only in exchange for foreign currency or paid for by cheque drawn on an external account. It will therefore be a requirement for the applicant to attach to a Form AT a letter from a commercial bank certifying that foreign currency was exchanged for kwacha or that payment is from an external account.

All other directives in A.D. Circular No. 19/81 of 21st July, 1981 remain the same.
