Re : Traffic Accident Involving A.N.C. Vehicle

I am seeking assistance from your office on the above mentioned matter.

My VW Kombi was hit by an A.N.C. vehicle on 7/I/89. My Kombi was being driven by my father in law, Simon Chikwekwe and the A.N.C. vehicle was being driven by George Tau, a member of the organisation.

Mabelreign Traffic Section attended the accident, their ref is 8/89 and Police Officer Rwafa dealt with the case. After assessing the accident the police concluded that George Tau is the one who caused the accident by driving without due care. They told me that they were going to send the case to court for a second assessment because such organisations like A.N.C. at times do not face criminal charges. The outcome from the court was that George Tau should pay \$40 (forty dollars) fine for driving without due care.

To this end Police Officer Rwafa started searching for Geoge Tau but could not find him until 13/II/89 the day he deposited the fine. By then I had already put my vehicle under repairs for a total cost of \$2118.83 (two thousand one hundred and eighteen dollars and eighty three cents). As my vehicle's insurance was third-party, I had to pay cash for the repairs.

I then summoned George Tau claiming for these damages. Efforts to find him by the messenger of court were fruitless until 6/4/90 when I wrote to the A.N.C. Chief Representative, Mr Max Mlonyeni. Verbally, he promised that beyond doubt his organisation will pay. Since then I have had several telephone conversations with him and his word was always "in principle we will pay you but it is being worked out within the organisation".

On 4/6/90 I phoned his office as a follow-up of his promise. I was told that he was not in. Ellen who is his secretary asked me what I wanted and I told her. She told me a different story. She said it was agreed upon by members of the organisations that the money should be claimed from their (A.N.C.) insurance.

I phoned Heritage Insurance and they told me that they did not have any file for the case therefore they couldnt entertain it. I phoned back to Ellen and she tried to phone the Insurance people and she was told that the case cannot be dealt with since the accident happened nearly 1¹/₂ years ago and yet it was supposed to be reported to the insurance within 21 days.


For the past three days Ellen had promised to come out with an answer from her superiors but she has not phoned. As I personally see it, they are not willing to pay from their organisation although they admit it was their fault that they did not report the accident within 21 days to their insurance company.

Attached is a copy of a report from the Police.
