



P R E S S R E L E A S E

STATEMENT BY THE SPOKESMAN OF THE FEDERAL SECRETARIAT FOR
FOREIGN AFFAIRS OF THE S.F.R. OF YUGOSLAVIA CONCERNING THE
SIGNING OF THE AGREEMENTS BETWEEN ANGOLA, CUBA AND REPUBLIC
OF SOUTH AFRICA AND BETWEEN ANGOLA AND CUBA IN NEW YORK,
DECEMBER 22ND, 1988

The attainment of the agreements on the political solution of the crisis prevailing in South-West Africa and on the start of implementation of the UNSC Resolution 435 concerning achievement of independence of Namibia, accomplished in New York, December 22nd, 1988, constitutes an event of great importance not only for the participating countries but in a much broader sense. This confirms that the awareness of the need for changes in international relations has become widespread and that such ideas and the according behaviour have been encompassing an ever broader range of questions pertaining to international relations.

It is with great attention and interest that Yugoslavia followed all phases of the quadripartite negotiations from the very outset. She considered this process as very positive and expected its outcome with optimism.

It is well known that concerning southern Africa Yugoslavia has been, from the very beginning, actively in favour of a consistent implementation and complete application of all pertinent decisions of the UN and of the Non-Aligned Movement, supporting, simultaneously, every peaceable initiative apt to lead to comprehensive political solution of this hotbed of crisis. This has been in harmony with Yugoslavia's general support of all progressive trends on the African Continent as well as with her support of the struggle of the peoples of Africa for the complete de-colonisation, independence and national emancipation.

The signing of these important agreements concluded the lengthy process of negotiations in which all participating sides demonstrated their goodwill, flexibility and readiness to come to a compromise, and represents a decisive turn towards attaining a comprehensive solution of the crisis in the region of southern Africa.

We consider it especially significant to stress at this particular moment that an all-embracing and lasting peace in the region can be achieved only on the basis of solutions acceptable and in the interests of all Front-Line States, notably of Angola, and also of SWAPO and the Liberation Movements of South Africa. We expect that the pacific process, thus initiated and conceived, will continue to develop and will contribute to the elimination of racial discrimination and apartheid in the RSA, through which would be realised the age-long aspirations of the majority population of that country.


We point out our expectation that the parties signatory to the agreements and other influential factors will justify the trust laid in them on the part of the broader international community by strictly abiding by the obligations accepted and by further peaceful and constructive activities and that they will contribute towards conditions necessary for lasting peace, security, good-neighbourly relations and unimpeded development of all countries in the region.

This spy was recruited in 1981 by South African Intelligence Services. Her military and agent numbers are W89853P and R5407 respectively.




