# VIOLENCE AND SELF DEFENCE

Conference mooted

GOVERNMENT is to call a multiparty conference to find a way of ending township violence. Law and Order Minister Adriaan Vlok said yesterday.

He also slapped a ban on carrying pangas, axes and bush knives in "conflict situations", but refused to extend the ban to traditional weapons, which he identified as spears, sticks, knob-kerries and shields.

And in a stinging attack on the ANC, he told a news conference that despite all the measures to curb the killings the violence continued "apparently with the ANC in every case the catalyst".

# Conference rejected

THE ANC and PAC yesterday rejected government's call for a multi-party conference on ways to end township violence.

ANC deputy president Nelson Mandela said at a news conference that Law and Order Minister Adriaan Vlok's call for a multiparty conference was "a propaganda ploy" in preparation for President FW de Klerk's visit to Europe.

He addressed reporters after eight members of the National Conference of Churches (NCC), led by Rev Frank Chikane and Louw Alberts, met the ANC National Executive Committee.

Mandela said there was no point in meeting on the issue because government knew exactly what to do to end the violence — "and we are not going to be engaged in any discussions which, in our view, are not intended to address the matter seriously".

#### Call for defence units

TEN more people were killed in Soweto and Alexandra in continuing violence at the weekend – against a backdrop of a call by ANC leader Mr Nelson Mandela that people should form self-defence units.

Mandela urged a crowd of about 5 000 at the mass funeral of violence victims in Alexandra on Saturday to establish self-defence units.

If it is okay for whites to have neighbourhood watch units then it should be equally okay for blacks to establish defence units.

"The aim of defence units is not to carry armed operations against the government and its installations but to protect the communities from a third force hiding behind ethnic violence," he said. - Sowetan 15/4/91

#### Self-defence document

THE ANC's draft proposals for the formation of township self-defence units have already been widely distributed among members of the ANC and its allies, Cosatu assistant general secretary Sydney Mafumadi said yesterday.

Mafumadi, chairman of the ANC-Cosau-SACP tripartite alliance's working committee on violence, said the committee had commissioned the booklet and that it had been produced by the ANC...

The booklet, entitled For the Sake of Our Lives - Guidelines for the Formation of People's Self-Defence Units, envisages paramilitary township defence structures operating under the guidance of the ANC's armed wing Umkhonto we Sizwe.

The ANC said yesterday the document was produced in November last year.

Mafumadi said the document had reached all parts of SA where the alliance had an organised presence.

"It is intended to facilitate discussion around the issue of self-defence. On the basis of the feedback we receive, the draft might have to be reworked." - Business Day 17/4/91

#### Police warning

THE Ministry of Law and Order yes-

terday issued a stern warning that it would not allow so-called "self-defence units" to take over the functions of the police.

A spokesman for the Ministry, Captain Craig Kotze, said in Cape Town yesterday that the police were totally opposed to all private political armies across the spectrum, including the Wenkommando's of the extreme right and the ANC's self-defence units. - Citizen 15/4/91

#### Govt responds

CIVIL war could erupt if the ANC carries out its intention to form defence units in strife-torn townships, the police have warned...

However, the government is showing signs of readiness to meet some of
the ANC's ultimatum demands for
measures to end township violence.

Although the government is reluctant to be seen to be reacting to the ANC's demands – which might suggest that the ANC has the initiative – it has made clear that further action on violenceis imminent.

Herstigte Nasionale Party leader Jaap Masais has reacted to ANC Youth League leader Peter Mokaba's weekend statement that the ANC has called for weapons to be seized from white rightwingers.

Mr Mokaba has said the plan was part of a "peace offensive" aimed at halting the growing violence...

Constitutional Development Deputy Minister Roelf Meyer said in an interview last night that the government was looking at steps to end the violence.

This was not being done with a view to meeting any particular demands, he added.

And Constitutional Development Minister Dr Gerrit Viljoen said on SABC-TV that the government accepted that it was its responsibility to end the ongoing violence...

## Units will go ahead

#### No contradiction

AN ANC document calling for armed defence units to be formed in the townships was "not a contradiction to the call for disarmament at public rallies or other mass gatherings", an ANC spokesman said yesterday.

"Self-defence units are aimed at protecting the people against attacks. In the instance where communities may be armed, such weapons will not be carried in marches or at public rallies.

"Any weapons at the disposal of such units will be purely for self protection," the ANC said.

#### Barriers erected

THE Maritzburg township of Slangspruit looked like a World War 2 battleground yesterday as residents set up road barriers to stop people going to an Inkatha Freedom Party prayer meeting at nearby Imbali.

The barriers across 500 m of roadway included burning car tyres, scrap cars, stones, boulders, broken bottles, a steel toilet and other items. IFP supporters had to use another access road to get to the meeting. There were no other incidents.

Slangspruit residents claimed the barriers were put up because their houses were regularly shot at by people going to or from Inkatha meetings. Velaphi Ndlovu, a member of the KwaZulu legislative assembly, denied this. - Star 15/4/91

BARAGWANATH Hospital was a scene of blood, confusion and paid last night as more than 70 people were rushed in for treatment after police allegedly open fire on them in Soweto.

Men, women and children on stretchers and in wheelchairs queued in the casualty ward at Baragwanath last night, for medical attention...

Eyewitnesses said police shot them after a few hundred ANC supporters gathered to defend themselves against a threatened Inkatha attack...

The Star news team was outside the hostel just before the alleged shooting began. A large police and SADF contingent sat in Casspirs and vans on the bridge overlooking the Nancefield hostel, watching hundreds of armed Zulu warriors crouching in the grass.

When The Star tried to follow two Casspirs to the area where the ANC supporters were gathering, a Casspir parked across the road, blocking the entrance, while the other disappeared.

#### Harassment by SADF

# ANC, PAC agreement

THE ANC and PAC have agreed to a conference in August which, they believe, will lead to the establishment of a patriotic front of anti-apartheid forces.

The agreement was announced at a news conference in Harare last night at the end of their two-day meeting which was hailed as an "outstanding success".

They condemned Monday's announcement of the lifting of some trade sanctions against SA by the EC, saying their cause was being done a disservice.

ANC publicity chief Pallo Jordan, who read the ANC/PAC statement, reated his organisation's threat to government to break off talks if it did not meet its demands for the dismissal of key ministers and an end to violence by May 9.

Jordan said the ANC and PAC would retain their independence after the establishment of a patriotic front...

ANC intelligence chief Jacob Zuma said organisations which would be invited to join a proposed coalition would be mainly those which subscribed to the popular call for a constituent assembly.

Difference on local govt

CENTRALISED government or devolution of power to regional and local authorities is one of the major remaining issues to be decided during negotiations between government and the ANC.

Government sources confirmed this at the weekend after publication of draft ANC constitutional proposals which considerably reduced the areas of difference between them.

The ANC proposals show there are still huge differences between it and government on the division of power among component parts of a new government. Underlying the ANC proposals is adherance to its long-standing belief in strong centralised government delegating powers.

Government's policies is that devolved power to regional and local levels should be entrenched...

Leading ANC advocate Dullah Omar said entrenched devolution of power would mean a future national government would be unable to implement national policies to reduce historical inequalities. He said this, combined with government's proposals for minority or group protectionism, would nullify or frustrate majority rule.

# PRISONERS AND EXILES

More exiles expected

THE on-off exile repatriation programme gets under way again this week when 115 exiles return from Tanzania.

The group, expected to arrive on a charter flight on Thursday, will be the first from an East African country...

The move heralds a fresh breakthrough in the repatriation of exiles after last week's apparent breakdown in the process.

Government on Friday indemnified a further 1 208 people and granted special remission of sentence to 119 prisoners.

Islanders released

FORTY-ONE political prisoners were yesterday released from Robben Island in keeping with an agreement between the government and the ANC.

Those released yesterday were serving sentences ranging from five to 30 years and were convicted between 1981 and 1990.

The ANC and the government agreed in terms of the Pretoria Minute that all political prisoners be released and exiles indemnified by April 30.

The Robben Island 41 were met by Umkhonto we Sizwe chief of staff Chris Hani. They were among 119 prisoners, the latest to be reprieved by State President FW de Klerk, who should all be released by today.

ANC spokesman Saki Macozoma said the ANC had demanded the Ministry reveal how many people arrested for unrest-related offences were in jail for the organisation to determine how many those it described as political were still imprisoned.

"What is happening is that the government decides who to release and grant indemnity. There are more than 40 000 people waiting in exile and more than 2 000 inside the prisons," said Macozoma.

DR Kenneth Khosa, the exiled Soweto medical doctor arrested by Bophuthatswana police at the weekend and later handed to the SAP, has been released...

His detention baffled his family when both the homeland and SAP denied they were holding him.

Khosa was detained on Saturday afternoon by Bophuthatswana poilce at the Kopfontein border on his way home for the first time since leaving South Africa in 1976.

Some indemnified

A FURTHER 1 208 people had applied for and been granted indemnity, bringing the total number to 3 692, the Minister of Justice Mr Kobie Coetsee said on Friday.

The director-general (justice) announced in the Government Gazette on Friday that 1 208 people who had applied for indemnity for undergoing military training contrary to the provisions of the Terrorism Act had received it.

Death row reprieve

CONVICTED killers Robert McBride, Barend Strydom and 15 other death row prisoners were saved from the gallows last night in a move the ANC has described as "an act of good faith".

LOCAL GOVERNMENT Metropolitan chamber

LEADING Soweto Civic Association official Cyril Ramaphosa and Transvaal MEC for local government Olaus van Zyl expressed surprise yesterday at the apparent about-turn by the Civics Association of Southern Transvaal (Cast) on participation in the newly launched Witwatersrand Metropolitan Chamber.

Ramaphosa said his organisation and the other civic associations which signed the metropolitan chamber constitution were not so "politically naive" as to get involved in anything based on racial representation.

"We are refuting the allegations by Cast that the chamber is based on racial representation and is aimed at undermining national political demands for a constituent assembly and an interim government.

"We will be meeting Cast within days to enlighten them about the true nature of the chamber," Ramaphosa said...

ANC spokesman Gill Marcus said the organisation would meet Cast soon to find out its stance on the newly constituted metropolitan chamber. - Business Day 15/4/91

Civic stays out

ADMINISTRATIVE and political problems plaguing Katlehong had prompted three other southeast Rand towns to form a joint administration and services base with the township, Germiston town clerk Tony Heyneke said yesterday.

Heyneke said the municipalities of Germiston, Bedfordview, Palm Ridge and Katlehong had recently committed themselves to the formation of the South East Rand Co-ordinating Committee (Sercom)...

Asked if the Sercom could be seen as a step towards the single-tax base concept and whether it would solve Katlehong's financial problems, Heyneke said: "We hope it will form the basis of that concept, but the councils felt that the political question should be left for discussion at national level.

"The financial position of Katlehong has not been discussed because the local civic association refuses to take part in talks until the black local council is excluded."

# EDUCATION Rival teacher body

A Cosas official in the Southern Transvaal, Mr Aaron Moela, said the organisation's executive yesterday visited various townships to assess the situation as the regional office had not called for any stayaway.

In a statement issued at a meeting in Newcastle, Northern Island, they also urged Western governments to provide "massive development aid" to black South Africans. They said this aid should be devoted to housing, land, education and health services and should be controlled "by representatives of those who have been oppressed". - Citizen 15/4/91

Food prices hit

FOOD prices have hit consumers in the stomach in the past year, with steady hikes continuing to outstrip the official inflation rate.

Central Statistical Service's consumer price index figures show food prices have been going up at an annual rate of over 15% since the beginning of 1990.

There have been particularly steep price rises for milk, milk products and eggs.

Fresh meat prices have climbed steadily, along with those for grain, while fruit price increases have been held at a high level of around 25% year-on-year...

The situation is unlikely to improve this year, with the introduction of VAT in October expected to exacerbate sharp price rises.

All foodstuffs now excluded from GST will be subject to VAT, barring brown bread and mealie meal.

Lower income earners are hardest hit by food prices because they spend about 55% of their income on basic items – food, clothing, footwear, rent and transport. This can be compared with the 28% that higher income earners spend on basic items.

#### World Bank interest

The interest is significant. SA is a paid-up shareholder of the bank and has ritually attended annual meetings, despite the fact that apatheid has limited the relationship to almost nothing...

But what can SA gain from growing contact? Critics say World Bank programmes, and those of its associate the IMF, have often been disastrous in Africa...

The problem is that many African countries are now hopelessly in debt. Debt servicing uses up vast amounts of foreign exchange earned from exports. In the worst cases, such as Mozambique, this is 100% of export earnings...

A SENIOR Angolan army officer has claimed that South Africa is air-dropping military supplies to Unita troops fighting a major battle for the town of Luena.

He also said that white men seen with the Unita forces at Luena were assumed to be South Africans and that South Africans were directing the Unita artillery in the battle.

This is believed to be the first time the MPLA government has claimed direct involvement by South African forces in Angola since the SADF withdrew from that country in 1989 as part of the settlement that led to independence for Namibia. - Star 15/4/91
